APPLICATION FOR RIGHT-OF-ENTRY TO CONSTRUCT ROAD IN E $\frac{1}{2}$ OF SECTION 36, T. 24 N., R. 7 E., S.B.B.& M., INYO COUNTY, DIVISION OF HIGHWAYS - W.O. 3329.

An application was received from Division of Highways on September 3, 1959, for a right-of-way across school lands in the E $\frac{1}{2}$ of Section 36, T. 24 N., R. 7 E., S.B.B.& M.. In order to fulfill the trust conditions impressed upon the State Lands Commission, it is proposed that the Division of Highways acquire the right-of-way by purchase.

Because of the time required for purchase, the Division of Highways has requested a right-of-entry permit in the interim in order to complete the construction of the highway.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE DIVISION OF HIGHWAYS A RIGHT-OF-ENTRY PERMIT ACROSS SCHOOL LANDS IN THE E $\frac{1}{2}$ OF SECTION 36, T. 24 N., R. 7 E., S.B.B.& M., AS SET FORTH IN EXHIBIT "A" ATTACHED HERETO AND HEREBY MADE A PART HEREOF.

Permission is hereby granted to enter upon the following parcel of land:

A portion of the E $\frac{1}{2}$ of Section 36, T. 24 N., R. 7 E., S.B.B.& M., situate in Inyo County, and delineated upon tracings forwarded the State Lands Division with your letter of September 2, 1959 requesting a right-of-way over said Parcel No. 711 for the purpose of construction and protection of a public highway.

It is understood and agreed that this permission is not a waiver in any way of the right to compensation for such land or of any remedy authorized by law to secure payment therefor; or to the rights of the State Lands Division to retain access to and across State school lands within said Section 36.

This permission is granted on the understanding that the Division of Highways will hereafter, without unnecessary delay, negotiate with the undersigned State Lands Commission within six months from the date of this right-of-entry, the date and terms of payment for the land hereinabove described.
