An application dated July 16, 1959 has been received from Division of Highways for a highway right-of-way across school lands in the W_2^1 , the NE_4^1 and the N_2^1 of the SE_4^1 of Section 36, T. 3 N., R. 25 E., M.D.B.& M., situate in Mono County. In order to fulfill the trust conditions impressed upon the State Lands Commission, it is proposed that the Division of Highways acquire the right-of-way by purchase.

Because of the time required for purchase, the Division of Highways has requested a right-of-entry permit in the interim in order to complete the construction of the highway.
