MINUTE ITEM

5. APPLICATION FOR DREDGING PERMIT, SAN DIEGO BAY, SAN DIEGO COUNTY, CITY OF CHULA VISTA - W.O. 3558, P.R.C. 2583.9.

After consideration of Calendar Item 40 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION FINDS THAT THE ACTION SPECIFIED IN THE APPLICATION OF THE CITY OF CHULA VISTA, DATED APRIL 11, 1960, WILL NOT UNREASONABLY INTER-FERE WITH THE MAINTENANCE OR USE OF THE LANDS INVOLVED FOR RECREATIONAL PURPOSES OR PROTECTION OF SHORE PROPERTIES, AND AUTHORIZES THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO THE CITY OF CHULA VISTA AUTHORIZING THE DREDGING OF APPROXIMATELY 200,000 CUBIC YARDS OF MATERIAL WITHOUT THE PAYMENT OF ROYALTY FROM THE FOLLOWING-DESCRIBED AREA IN SAN DIEGO BAY, SAN DIEGO COUNTY:

BEGINNING AT A POINT ON THE PIERHEAD LINE, SAID POINT BEING S. 25° 54' 03" E. A DISTANCE OF 706.59 FEET FROM STATION 320 A OF THE PIERHEAD LINE, SAN DIEGO BAY, CALIFORNIA, SAID STATION HAVING COORDINATES 40,864.39 S/20, 946.34 E., THE ORIGIN OF COORDINATES BEING THE U.S. COAST GEODETIC SURVEY STATION "OLD TOWN"; THENCE DUE WEST A DISTANCE OF 730.04 FEET; THENCE DUE SOUTH A DISTANCE OF 650 FEET; THENCE DUE EAST A DISTANCE OF 1069.96 FEET TO THE PIERHEAD LINE; THENCE A DISTANCE OF APPROXIMATELY 700 FEET ALONG THE PIERHEAD LINE TO THE POINT OF BEGINNING, CONTAINING 15.5 ACRES, MORE OR LESS.

APPLICATION FOR DREDGING PERMIT, SAN DIEGO BAY, SAN DIEGO COUNTY, CITY OF CHULA VISTA - W.O. 3558.

An application has been received from the City of Chula Vista for a permit to dredge in an area of submerged lands of the State adjacent to the tide and submerged lands granted to that City under Statutes of 1959.

The dredging on ungranted State land will be for the purpose of extending into deep water the channel proposed to be dredged on the granted lands in connection with harbor development. The ungranted State lands to be dredged contain approximately 15.5 acres. It is proposed that the dredged material, estimated at 200,000 cubic yards, will be deposited on tide and submerged lands within the grant to provide a portion of the required material for a 75-acre tide and submerged land fill preparatory to improvements required under terms of the grant.

The U. S. Corps of Engineers has issued a permit authorizing the conduct of dredging operations at the location described in the application, and the State Department of Natural Resources has reported that the proposed operations will not interfere with the recreational use of the lands littoral to the tide and submerged lands involved in the application. The office of the Attorney General has approved the application as to compliable with applicable provisions of law and the Rules and Regulations of the State Lends Commission.

IT IS RECOMMENDED THAT THE COMMISSION FIND THAT THE ACTION SPECIFIED IN THE APPLICATION ON THE CITY OF CHULA VISTA, DATED APRIL 11, 1960, W__L NOT UNREASONABLY INTERFERE WITH THE MAINTENANCE OR USE OF THE LANDS INVOLVED FOR RECREATIONAL PURPOSES OR PROTECTION OF SHORE PROPERTIES, AND AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO THE CITY OF CHULA VISTA AUTHORIZING THE DREDGING OF APPROXIMATELY 200,000 CUBIC YARDS OF MATERIAL WITHOUT THE PAYMENT OF ROYALTY FROM THE FOLLOWING-DESCRIBED AREA IN SAN DIEGO BAY, SAN DIEGO COUNTY:
