Lease P.R.C. 2065.1 was issued January 1, 1958, for two years to Dorothy E. Cotton for a strip of submerged lands 40 feet in width riverward and 550 feet in length along the left bank of the Sacramento River one-half mile upstream from the confluence of the Sacramento and American Rivers.
