APPLICATION FOR SEWER OUTFALL EASEMENT, TIDE AND SUBMERGED LANDS OF CARQUINEZ STRAIT, CONTRA COSTA COUNTY, CROCKETT-VALONA SANITARY DISTRICT -W.O. 3553.

An application has been received from Crockett-Valona Sanitary District for an easement 20 feet in width and 46 feet in length, containing 0.021 acre, more or less, for a sever outfall line into tide and submerged lands of Carquinez Strait.

The site adjoins an easterly bridge pier on the southerly side of Crockett-Vallejo Bridge, and also adjoins the site leased to C & H Sugar Refining Corporation under Lease P.R.C. 2546.1. The C & H Sugar Refining Corporation recommends the granting of this easement. No fees or charges are required.
