

MINUTE ITEM

6. APPLICATION FOR BRIDGE EASEMENTS, SUBMERGED LAND OF LAIRD SLOUGH AND SAN JOAQUIN RIVER NEAR GRAYSON, STANISLAUS COUNTY, COUNTY OF STANISLAUS - W.O. 3573, P.R.C. 2597.9.

After consideration of Calendar Item 15 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO GRANT TO STANISLAUS COUNTY A 49-YEAR PERMIT FOR TWO EASEMENTS, EACH 200 FEET IN WIDTH, ACROSS THE SUBMERGED LANDS OF SAN JOAQUIN RIVER AND LAIRD SLOUGH, FOR RIGHTS-OF-WAY FOR TWO BRIDGES, SITUATE IN STANISLAUS COUNTY, DESCRIBED AS FOLLOWS:

A STRIP OF LAND 200 FEET WIDE SITUATE IN THE LAIRD SLOUGH EAST OF THE TOWN OF GRAYSON, STANISLAUS COUNTY, STATE OF CALIFORNIA, THE CENTERLINE OF SAID STRIP PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER, SECTION 25, TOWNSHIP 4 SOUTH, RANGE 7 EAST, M.D.B. & M.; THENCE SOUTH $0^{\circ} 39' 40''$ WEST ALONG THE EAST LINE OF SAID SECTION A DISTANCE OF 1,247.49 FEET; THENCE NORTH $89^{\circ} 32' 20''$ WEST 3,371 FEET MORE OR LESS TO THE LOW WATER LINE ON THE RIGHT BANK OF THE SAID SLOUGH, SAID POINT BEING THE TRUE POINT OF BEGINNING; THENCE NORTH $89^{\circ} 32' 20''$ WEST ALONG THE CENTERLINE OF THE AFORESAID 200-FOOT STRIP A DISTANCE OF 110 FEET MORE OR LESS TO THE LOW WATER LINE ON THE LEFT BANK OF THE SAID SLOUGH, CONTAINING 0.505 ACRE, MORE OR LESS.

A STRIP OF LAND 200 FEET WIDE SITUATE IN THE SAN JOAQUIN RIVER, SOUTHEAST OF THE TOWN OF GRAYSON, STANISLAUS COUNTY, STATE OF CALIFORNIA, THE CENTERLINE OF SAID STRIP PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF THE GRAYSON CEMETERY AS PER MAP FILED IN VOLUME 1, RECORD OF SURVEYS AT PAGE 125 STANISLAUS COUNTY RECORDS; THENCE NORTH $45^{\circ} 08'$ EAST ALONG THE SOUTH LINE OF SAID CEMETERY A DISTANCE OF 1,748.98 FEET; THENCE SOUTH $44^{\circ} 52'$ EAST 45 FEET; THENCE NORTH $45^{\circ} 08'$ EAST A DISTANCE OF 90 FEET MORE OR LESS TO THE LOW WATER LINE ON THE LEFT BANK OF THE SAN JOAQUIN RIVER, SAID POINT BEING THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE NORTH $45^{\circ} 08'$ EAST ALONG THE CENTERLINE OF THE AFORESAID 200-FOOT STRIP A DISTANCE OF 120 FEET MORE OR LESS TO THE LOW WATER LINE ON THE RIGHT BANK OF THE AFORESAID RIVER, CONTAINING 0.551 ACRE, MORE OR LESS.

THE CONSIDERATION FOR THE ISSUANCE OF THE PERMIT IS THE PUBLIC USE AND BENEFIT.

APPLICATION FOR BRIDGE EASEMENTS, SUBMERGED LAND OF LAIRD SLOUGH AND SAN JOAQUIN RIVER NEAR GRAYSON, STANISLAUS COUNTY, COUNTY OF STANISLAUS - W.O. 3573.

An application has been received from the County of Stanislaus for bridge right-of-way easements, 200 feet in width, across the San Joaquin River and across Laird Slough near Grayson. When constructed, the bridges will replace those which now serve the Grayson Road. The change in location is occasioned by a realignment of the road. No fees or rental are required.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO GRANT TO STANISLAUS COUNTY A 49-YEAR PERMIT FOR TWO EASEMENTS, EACH 200 FEET IN WIDTH, ACROSS THE SUBMERGED LANDS OF SAN JOAQUIN RIVER AND LAIRD SLOUGH, FOR RIGHTS-OF-WAY FOR TWO BRIDGES, SITUATE IN STANISLAUS COUNTY, DESCRIBED AS FOLLOWS:

A STRIP OF LAND 200 FEET WIDE SITUATE IN THE LAIRD SLOUGH EAST OF THE TOWN OF GRAYSON, STANISLAUS COUNTY, STATE OF CALIFORNIA, THE CENTERLINE OF SAID STRIP PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER, SECTION 25, TOWNSHIP 4 SOUTH, RANGE 7 EAST, M.D.B. & M.; THENCE SOUTH $0^{\circ} 39' 40''$ WEST ALONG THE EAST LINE OF SAID SECTION A DISTANCE OF 1,247.49 FEET; THENCE NORTH $89^{\circ} 32' 20''$ WEST 3,371 FEET MORE OR LESS TO THE LOW WATER LINE ON THE RIGHT BANK OF THE SAID SLOUGH, SAID POINT BEING THE TRUE POINT OF BEGINNING; THENCE NORTH $89^{\circ} 32' 20''$ WEST ALONG THE CENTERLINE OF THE AFORESAID 200-FOOT STRIP A DISTANCE OF 110 FEET MORE OR LESS TO THE LOW WATER LINE ON THE LEFT BANK OF THE SAID SLOUGH, CONTAINING 0.505 ACRE, MORE OR LESS.

A STRIP OF LAND 200 FEET WIDE SITUATE IN THE SAN JOAQUIN RIVER, SOUTHEAST OF THE TOWN OF GRAYSON, STANISLAUS COUNTY, STATE OF CALIFORNIA, THE CENTERLINE OF SAID STRIP PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE SOUTHWEST CORNER OF THE GRAYSON CEMETERY AS PER MAP FILED IN VOLUME 1, RECORD OF SURVEYS AT PAGE 125 STANISLAUS COUNTY RECORDS; THENCE NORTH $45^{\circ} 08'$ EAST ALONG THE SOUTH LINE OF SAID CEMETERY A DISTANCE OF 1,748.98 FEET; THENCE SOUTH $44^{\circ} 52'$ EAST 45 FEET; THENCE NORTH $45^{\circ} 08'$ EAST A DISTANCE OF 90 FEET MORE OR LESS TO THE LOW WATER LINE ON THE LEFT BANK OF THE SAN JOAQUIN RIVER, SAID POINT BEING THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE NORTH $45^{\circ} 08'$ EAST ALONG THE CENTERLINE OF THE AFORESAID 200-FOOT STRIP A DISTANCE OF 120 FEET MORE OR LESS TO THE LOW WATER LINE ON THE RIGHT BANK OF THE AFORESAID RIVER, CONTAINING 0.551 ACRE, MORE OR LESS.
