APPLICATION FOR APPROVAL OF SUBLEASE UNDER P.R.C. 2364.2, SECTION 36, T. 1 N., R. 1 W., M.D.M., CONTRA COSTA COUNTY, LINDSEY H. SPIGHT -W.O. 3642.

Lease P.R.C. 2364.2, covering Lot 4 and the W_2 of Lot 2, Section 36, T. 1 N., R. 1 W., M.D.M., was issued to Lindsey H. Spight for 15 years beginning March 16, 1959, with provision for two renewal periods of 10 years each.

An application has been received from Lindsey H. Spight, d.b.a. Diablo Communications Center, pursuant to the terms of lease P.R.C. 2364.2, for approval of a sublease to Walnut Creek Canning Company, a corporation, connecting July 1, 1960 for a portion of the leased site sufficient for the operation of a mobile transmission and receiving station. The sublease is to run for an indefinite period not to exceed the tenure of the lessee of lease P.R.C. 2364.2.

The Communications Division of the Department of Finance reported on July 11, 1960 that there is no objection to this sublease. The statutory filing fee has been paid. Land rental is paid to March 16, 1961.
