A STRIP OF TIDE AND SURMERGED LAND 250 FEET IN WIDTH, LOCATED IN GEORGIANA SLOUGH, SACRAMENTO COUNTY, THE CENTERLINE BEING DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK ALONG THE EAST BANK OF GEORGIANA SLOUGH WHICH BEARS S. 18° 10' 15" W., 125.48 FEET, AND S. 85° 43' 45" W., 55 FEET, MORE OR LESS, FROM A $1\frac{1}{4}$ INCH IRON PIPE MARKING THE SOUTHWEST CORNER LOT 16, MAP OF CLIRA B. LORD PROPERTY, BOOK 3 OF SURVEYS, PAGE 30, SACRAMENTO COUNTY RECORDS; THENCE FROM SAID POINT OF BEGINNING S. 85° 43' 45" W., 189 FEET, MORE OR LESS, TO THE ORDINARY HIGH WATER MARK ALONG THE WEST BANK OF GEORGIANA SLOUGH, CONTAINING 1.08 ACRES, MORE OR LESS.

APPLICATION FOR BRIDGE EASEMENT RIGHT-OF-WAY ACROSS THE TIDE AND SUBMERGED LANDS OF GEORGIANA SLOUGH AT WALNUT GROVE, SACRAMENTO COUNTY, COUNTY OF SACRAMENTO - W.O. 3678.

An application has been received from the County of Sacramento for a bridge easement right-of-way across Georgiana Slough at Walnut Grove in Sacramento County to replace the existing bridge connecting Andrus and Tyler Islands. The new swing-type bridge will provide a minimum clear navigable opening 30 feet wide, and will carry passing loads of 20-ton trucks with 16-ton trailers. The estimated \$427,000 cost of the approaches and structures is to be met with Federal aid and matching County money. The State tide and submerged lands to be occupied consist of a strip 250 feet in width and 189 feet in length containing approximately 1.08 acres. No fees or rentals are to be charged.
