APPLICATION FOR PERMIT TO CONSTRUCT SHORE-PROTECTIVE WORKS BETWEEN THE WEST CITY LIMITS AND LIGHTHOUSE POINT, CITY OF SANTA CRUZ - W.O. 3669.

An application has been received from the City of Santa Cruz for a permit to construct shore-protective works extending onto State sovereign lands of the Pacific Ocean lying below the mean low tide line between the west limits of the City of Santa Cruz and Lighthouse Point, which is the westerly headland of Monterey Bay. A Legislative grant (Statutes of 1871-2) conveyed the tidelands at the project sites to the City of Santa Cruz.

The project, known as Beach Erosion Control-West Cliff Drive Section-Phase 1, is a cooperative project involving the U.S. Army Corps of Engineers, the California State Department of Water Resources, and the City of Santa Cruz in the construction of fourteen short dikes and revetted sections faced with stone, which would weigh between four and six tons each. The structures are so designed and placed as to stop the serious loss of valuable upland property resulting from wave action.

Commission approval of the requested permit is authorized by Section 6321 of the Public Resources Code:
