APPLICATION FOR LEASE, CABIN SITE, TIDE AND SUBMERGED LANDS ALONG RIGHT BANK OF PETALUMA RIVER, VICINITY OF BLACK POINT, MARIN COUNTY, ANTHONY BANDER - W.O. 3697.

An application has been received from Anthony Bander for a new lease to replace Lease P.R.C. 586.1 expiring on September 30, 1960. The lease is to be issued for a period of ten years, covering approximately 0.131 acre of tide and submerged lands along the right bank of the Petaluma River at Black Point in Marin County. The minimum annual rental of \$65, previously established by the Commission, would apply, based upon an estimated value of \$500 for the property which is occupied in part by a cabin-type residence and a wharf. The filing fee has been paid.
