MINUTE ITEM

4. ISSUANCE OF RIGHT-OF-WAY EASEMENTS TO THE DIVISION OF HIGHWAYS, STATE OF CALIFORNIA - W.O. 3741, P.R.C. 2687.9, and W.O. 3765, F.R.C. 2688.9.

Commissioner Carr questioned whether the public interest is being served best by turning areas of State lands over from one State agency to another without any payment of fees.

The Executive Officer explained that under Section 101 of the Streets and Highways Code, the Legislature prescribed that the Division of Highways, by filing a plat with the Surveyor General (whose duties have since been taken over by the State Lands Commission) would be given authorization to occupy such lands as are needed for highway purposes. However, this refers only to submerged lands of the State. Rentals are charged for crossing vacant State school lands.

Commissioner Carr then recommended looking into the equities of the particular situations.

The Executive Officer suggested that a staff inventory be made of the number of authorizations of this type of right-of-way which have been issued. He also called to the attention of the Commission that sand and gravel are being removed from State lands for highway construction purposes without the payment of any fee, whereas such material has a market value and can be sold by the State Lands Commission to private contractors.

UPON MOTION MADE BY COMMISSIONER CARR, SECONDED BY COMMISSIONER ANDERSON, AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED DIRECTING THE STAFF TO MAKE A STUDY OF RIGHT-OF-WAY LASEMENTS ISSUED TO THE STATE DIVISION OF HIGHWAYS WITH A VIEW TOWARD INCREASING THE REVENUES OF THE STATE BY MAKING EQUITABLE CHARGES FOR ALL SUCH EASEMENTS.

A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO EXECUTE AN EASEMENT AGREEMENT WITH THE STATE DIVISION OF HIGHWAYS, PURSUANT TO SECTION 101.5 OF THE STREETS AND HIGHWAYS CODE, FOR A RIGHT-OF-WAY 260 FRET IN WIDTH AND AVERAGING A CROSSING LENGTH OF 740 FEET, CONTAINING 4.8 ACRES, MORE OR LESS, IN SECTION 29, T. 27 N., R. 3 W., M.D.B.& M., NEAR RED BLUFF, TEHAMA COUNTY, AS DELINEATED ON STATE DIVISION OF HIGHWAYS MAP, DIST. II-TEH-7-B, RB1, SHEET 1.

An application has been received from the State Division of Highways, pursuant to Section 101.5 of the Streets and Highways Code, for enlargement of an existing easement across the Colorado River under P.R.C. 625.9 by the granting of two irregular parcels of land, Parcel 9777 (containing 6.24 acres) and Parcel 9620 (containing 2.83 acres) in Section 36, T. 6 S., R. 23 E., S.B.B.& M., adjoining the north and west side of the said existing easement.

The site is required for the Ehrenberg bridge, crossing the Colorado River near Blythe. No fees or charges are to be levied.
