

MINUTE ITEM

13. *APPLICATION FOR LEASE OF CERTAIN SCHOOL LANDS IN SAN BERNARDINO COUNTY, ELEVENTH NAVAL DISTRICT - W.O. 3571, P.R.C. 2709.2.

After consideration of Calendar Item 23 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE ELEVENTH NAVAL DISTRICT A FIVE-YEAR LEASE FOR AN AERIAL GUNNERY RANGE, COMMENCING JULY 1, 1960, AND EXTENDING TO JUNE 30, 1965, COVERING THE FOLLOWING-DESCRIBED AREA:

APPLICATION FOR LEASE OF CERTAIN SCHOOL LANDS IN SAN BERNARDINO COUNTY, ELEVENTH NAVAL DISTRICT - W.O. 3571.

An application has been received from the Eleventh Naval District to lease 4,215.40 acres of school lands in northwestern San Bernardino County, near Camp Irwin, for the period July 1, 1960, to June 30, 1965, for use as an aerial gunnery range. (See Exhibit "A") This lease would replace the Eleventh Naval District's Lease P.R.C. 1537.2, which expired on June 30, 1960.

The previously charged land rental of \$126.63 annually would be increased to \$3,775 annually, in proper relation to the current fair market value of the land. No fees or deposits are required by statute or regulations.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE ELEVENTH NAVAL DISTRICT A FIVE-YEAR LEASE FOR AN AERIAL GUNNERY RANGE, COMMENCING JULY 1, 1960 AND EXTENDING TO JUNE 30, 1965, COVERING THE FOLLOWING DESCRIBED AREA:
