PROPOSED OIL AND GAS LEASE, SANTA BARBARA COUNTY, W.O. 3880 (PARCEL 4).

On March 7, 1961 the Commission deferred consideration of lease-offer authorization for the area discussed hereinafter to the current meeting.

Fursuant to the sequential bidding procedure approved by the State Lands Commission on November 15, 1960, for use in oil and gas lease-offers of tide and submerged lands under the jurisdiction of the Commission,

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO OFFER A PARCEL OF TIDE AND SUBMERGED LANDS IN SANTA BARBARA COUNTY FOR OIL AND GAS LEASE, PURSUANT TO DIVISION 6 OF THE PUBLIC RESOURCES CODE.

THE LEASE AWARD IS TO BE MADE TO THE QUALIFIED BIDDER OFFEPING THE HIGHEST CASH-BONUS PAYMENT IN CONSIDERATION OF THE ISSUANCE OF AN CIL AND GAS LEASE.

THE BID-LEASE FORM TO BE UTILIZED FOR THE PARCEL SHALL BE THE FORM APPROVED AND ADOPTED BY THE COMMISSION ON NOVEMBER 15, 1960.

THE PROPOSED LEASE AREA IS NOT WITHIN THE KNOWN GEOLOGIC STRUCTURE OF ANY PRODUCING OIL OR GAS FIELDS.
