

MINUTE ITEM

17. PROPOSED OIL AND GAS LEASE, SANTA BARBARA COUNTY - W.O. 3880 (PARCEL 4).

Following presentation of Calendar Item 14 attached, the Executive Officer suggested that, in view of the action taken by the Commission authorizing the drilling of additional core holes on Parcel 4 (See Minute Item 2, page 6938), the closing date for bids on Parcel 4 should be set approximately ninety days hence, rather than the normal closing heretofore sixty days after Commission authorization.

UPON MOTION DULY MADE AND CARRIED, THE FOLLOWING RESOLUTION WAS ADOPTED:

THE EXECUTIVE OFFICER IS AUTHORIZED TO OFFER A PARCEL OF TIDE AND SUBMERGED LANDS IN SANTA BARBARA COUNTY FOR OIL AND GAS LEASE, PURSUANT TO DIVISION 6 OF THE PUBLIC RESOURCES CODE.

THE LEASE AWARD IS TO BE MADE TO THE QUALIFIED BIDDER OFFERING THE HIGHEST CASH-BONUS PAYMENT IN CONSIDERATION OF THE ISSUANCE OF AN OIL AND GAS LEASE.

THE BID-LEASE FORM TO BE UTILIZED FOR THE PARCEL SHALL BE THE FORM APPROVED AND ADOPTED BY THE COMMISSION ON NOVEMBER 15, 1960.

THE PROPOSED LEASE AREA IS NOT WITHIN THE KNOWN GEOLOGIC STRUCTURE OF ANY PRODUCING OIL OR GAS FIELDS.

PROPOSED OIL AND GAS LEASE, SANTA BARBARA COUNTY, W.O. 3880 (PARCEL 4).

On March 7, 1961, the Commission deferred consideration of lease-offer authorization for the area discussed hereinafter.

Pursuant to the sequential bidding procedure approved by the State Lands Commission on November 15, 1960, for use in oil and gas lease-offers of tide and submerged lands under the jurisdiction of the Commission,

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO OFFER A PARCEL OF TIDE AND SUBMERGED LANDS IN SANTA BARBARA COUNTY FOR OIL AND GAS LEASE, PURSUANT TO DIVISION 6 OF THE PUBLIC RESOURCES CODE.

THE LEASE AWARD IS TO BE MADE TO THE QUALIFIED BIDDER OFFERING THE HIGHEST CASH-BONUS PAYMENT IN CONSIDERATION OF THE ISSUANCE OF AN OIL AND GAS LEASE.
