THE EXECUTIVE OFFICER IS AUTHORIZED TO APPROVE A REVISION OF THE LEGAL DESCRIPTION IN LIFE-OF-STRUCTURE PERMIT P.R.C. 2677.9, ISSUED TO THE U. S. APPLICATION FOR APPROVAL OF REVISION OF LEGAL DESCRIPTION IN LEASE P.R.C. 2677.9 COVERING THE NORTH AND SOUTH JETTIES AT BODEGA BAY HARBOR, SONOMA COUNTY, UNITED STATES ARMY CORPS OF ENGINEERS - W.O. 3970.

Lease P.R.C. 2677.9, a life-of-structure permit, was issued to the U.S. Army Corps of Engineers on January 17, 1961, for the maintenance and operation of two existing jetties on tide and submerged lands seaward of Bodega Bay, Sonoma County, for the protection of Bodega Bay.

The Corps of Engineers compiled the description used in the permit from construction drawings for the jetties. A recent survey by the Corps of Engineers shows that the jetties were built on a slightly different alignment than proposed on the initial drawings. It has been requested that the legal description in the authorized lease be revised to define more accurately the actual location of the two jetties.
