18. SURVEY OF GRANT OF TIDE AND SUBMERGED LANDS TO THE CITY OF OAKLAND, ALAMEDA COUNTY, UNDER STATUTES OF 1960, CHAPTER 15 - W.O. 3610, P & C, GEO.-ALAMEDA CO.

After consideration of Calendar Item 1 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXECUTE A SERVICE AGREEMENT WITH THE CITY OF OAKLAND, ALAMEDA COUNTY, CALIFORNIA, ON BEHALF OF THE STATE LANDS COMMISSION AS CONTRACTOR, PROVIDING FOR SURVEYING SERVICES TO BE RENDERED TO THE CITY OF OAKLAND, PURSUANT TO THE PROVISIONS OF THE STATUTES OF 1960, CHAPTER 15, THE PAYMENT TO THE STATE LANDS COMMISSION FOR SAID SERVICES TO BE THE COMMISSION'S ACTUAL COSTS, BUT NOT TO EXCEED \$2000.

SURVEY OF GRANT OF TIDE AND SUBMERGED LANDS TO THE CITY OF OAKLAND, ALAMEDA COUNTY UNDER CH. 15/ST. 1960 - W.O. 3610.

Ch. 15/St. 1960 is an amendment to Ch. 390/St. 1909, under which certain presently unsurveyed tide and submerged lands were granted to the City of Oakland. Section 6359 of the Public Resources Code provides that the State Lands Commission shall, at the cost of the grantee, within two years from the effective date of such an amendment, survey, monument and record a plat of the lands originally granted by the Legislature.

In accordance with the foregoing, an agreement has been drawn up by the City of Oakland which provides for the rendering of the necessary surveying services by State Lands and the payment by the City of costs not in excess of \$2000 -- the Division's cost estimate for the work to be performed.

Section 13370(d) of the Government Code requires that the agreement be approved by the Department of Finance.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO EXECUTE A SERVICE AGREEMENT WITH THE CITY OF OAKLAND, ALAMEDA COUNTY, CALIFORNIA, ON BEHALF OF THE STATE LANDS COMMISSION AS CONTRACTOR, PROVIDING FOR SURVEYING SERVICES TO BE RENDERED THE CITY OF OAKLAND, PURSUANT TO THE PROVISIONS OF CH. 15/ST. 1960, THE PAYMENT TO THE STATE LANDS COMMISSION FOR SAID SERVICES TO BE THE COMMISSION'S ACTUAL COSTS, NOT TO EXCEED \$2000.
