

MINUTE ITEM

7. APPLICATION FOR DREDGING PERMIT, MARE ISLAND STRAIT, SOLANO COUNTY, CITY OF VALLEJO - W.O. 3976, P.R.C. 2756.9.

After consideration of Calendar Item 30 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION:

1. FINDS THAT THE ACTION SPECIFIED IN THE APPLICATION OF THE CITY OF VALLEJO WILL NOT UNREASONABLY INTERFERE WITH THE MAINTENANCE OR USE OF THE LANDS INVOLVED FOR RECREATIONAL PURPOSES OR PROTECTION OF SHORE PROPERTIES; AND
2. AUTHORIZES THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO THE CITY OF VALLEJO, AUTHORIZING THE DREDGING OF APPROXIMATELY 15,000 CUBIC YARDS OF MATERIAL WITHOUT THE PAYMENT OF ROYALTY FROM THE FOLLOWING-DESCRIBED AREA IN MARE ISLAND STRAIT, SOLANO COUNTY:

COMMENCING AT U. S. ENGINEER DEPARTMENT MONUMENT--82A AS SHOWN ON THE MAP TITLED "HARBOR LINES MARE ISLAND STRAIT CALIFORNIA" DATED FEBRUARY 14, 1940 AND REVISED APRIL 1958, FILED AT U. S. ENGINEER OFFICE, SAN FRANCISCO, CALIFORNIA; RUNNING THENCE SOUTH 57° 22' 47" WEST 378.08 FEET TO THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION, SAID POINT BEING IN THE PIERHEAD-BULKHEAD LINE AS DESCRIBED ON AFOREMENTIONED MAP; RUNNING THENCE ALONG SAID PIERHEAD BULKHEAD LINE NORTH 32° 37' 13" WEST 90.00 FEET; THENCE SOUTH 57° 22' 47" WEST 300.00 FEET; THENCE SOUTH 32° 37' 13" EAST 1500.00 FEET; THENCE NORTH 57° 22' 47" EAST 300.00 FEET; THENCE NORTH 32° 37' 13" WEST 1410.00 FEET TO THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION, CONTAINING 10.33 ACRES, MORE OR LESS.

APPLICATION FOR DREDGING PERMIT, MARE ISLAND STRAIT, SOLANO COUNTY, CITY OF VALLEJO - W.O. 3976.

An application has been received from the City of Vallejo for a permit to dredge in an area of submerged lands of the State adjacent to the tide and submerged lands granted to that City under Statutes of 1913.

The dredging on ungranted State land will be for the purpose of deepening the channel for the construction of a small craft harbor. The ungranted State lands to be dredged contain approximately 10.3 acres. It is proposed that this dredged material, estimated at 15,000 cubic yards, will be deposited on tide and submerged lands within the grant to provide a portion of the required material for the reclamation of a 20-acre tract adjacent to the proposed small craft harbor.

The U. S. Corps of Engineers has issued a permit authorizing the conduct of dredging operations at the location described in the application, and the State Department of Natural Resources has reported that the proposed operations will not interfere with the recreational use of the lands littoral to the tide and submerged lands involved in the application. The office of the Attorney General has approved the application as to compliance with applicable provisions of law and the rules and regulations of the State Lands Commission.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTION SPECIFIED IN THE APPLICATION OF THE CITY OF VALLEJO WILL NOT UNREASONABLY INTERFERE WITH THE MAINTENANCE OR USE OF THE LANDS INVOLVED FOR RECREATIONAL PURPOSES OR PROTECTION OF SHORE PROPERTIES; AND
2. AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO THE CITY OF VALLEJO, AUTHORIZING THE DREDGING OF APPROXIMATELY 15,000 CUBIC YARDS OF MATERIAL WITHOUT THE PAYMENT OF ROYALTY FROM THE FOLLOWING-DESCRIBED AREA IN MARE ISLAND STRAIT, SOLANO COUNTY:
