After consideration of Calendar Item 3 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO TEXACO INC. A GEOLOGICAL SURVEY PERMIT, IN CONFORMANCE WITH REGULATIONS ADOPTED BY THE COMMISSION, FOR THE FERIOD JULY 28, 1961, TO JANUARY 27, 1962, INCLUSIVE, AUTHORIZING THE CONDUCT OF GEOLOGICAL SURVEYS ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT SAN LUIS, SAN LUIS OBISPO COUNTY, AND THE PROLONGATION SEAWARD OF THE NORTHERLY LIMITS OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY. THIS FERMIT IS TO SUFERSEDE GEOLOGICAL SURVEY FERMIT P.R.C. 2483.1.

APPLICATION FOR GEOLOGICAL SURVEY PERMIT; SAN LUIS OBISPO, SANTA BARBARA, VENTURA, LOS ANGELES, AND ORANGE COUNTIES; TEXACO INC. - W.O. 4026.

An application has been received from Texaco Inc., requesting a geological survey permit covering an area of tide and submerged lands under the jurisdiction of the State Lands Commission in San Luis Obispo, Santa Barbara, Ventura, Los Angeles, and Orange counties, for the six-month period commencing July 28, 1961.

A portion of the above area is currently included in Geological Survey Permit P.R.C. 2483.1, issued to Texaco Inc., which expires November 15, 1961. The remainder of the area was previously included in a geological survey permit issued to Monterey Oil Company, which expired May 15, 1961. Exploration operations were formerly conducted jointly by Monterey and Texaco Inc.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO TEXACO INC. A GEOLOGICAL SURVEY PERMIT, IN CONFORMANCE WITH REGULATIONS ADOPTED BY THE COMMISSION, FOR THE PERIOD JULY 28, 1961, TO JANUARY 27, 1962, INCLUSIVE, AUTHORIZING THE CONDUCT OF GEOLOGICAL SURVEYS ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT SAN LUIS, SAN LUIS OBISPO COUNTY, AND THE PROLONGATION SEAWARD OF THE NORTHERLY LIMITS OF THE CITY OF NEWPORT BEACH, ORANGE COUNTY.
