

MINUTE ITEM

3. APPLICATION FOR APPROVAL OF A SUBMARINE CABLE ACROSS SUBMERGED LANDS OF MIDDLE RIVER BETWEEN UNION ISLAND AND DREXLER TRACT AT THE TRACY ROAD BRIDGE, SAN JOAQUIN COUNTY, THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY - W.O. 3904, P.R.C. 2770.9.

After consideration of Calendar Item 13 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXECUTE AN AGREEMENT WITH THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY, PURSUANT TO THE PROVISIONS OF SECTION 7901 OF THE PUBLIC UTILITIES CODE AND OF ATTORNEY GENERAL'S OPINION 52/56, IN THE FORM PREVIOUSLY ADOPTED BY THE COMMISSION, APPROVING THE LOCATION OF A SUBMARINE CABLE, WITH THE NECESSARY APPURTENANCES, ACROSS THE FOLLOWING-DESCRIBED PORTION OF LAND:

A PARCEL OF TIDE AND SUBMERGED LAND 50 FEET WIDE IN MIDDLE RIVER, BETWEEN DREXLER TRACT AND UNION ISLAND, SAN JOAQUIN COUNTY, APPROXIMATELY 4 MILES SOUTHWESTERLY OF HOLT, LYING 25 FEET ON EITHER SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK ON THE RIGHT BANK OF MIDDLE RIVER WHICH BEARS S. 40° 35' W., 36 FEET, MORE OR LESS, FROM STA. 81 + 68.92 AS SHOWN ON SAN JOAQUIN COUNTY SURVEY NO. 4700, ENTITLED "SURVEY OF TRACY ROAD NO. 923"; THENCE S. 13° 00' E., 250 FEET, MORE OR LESS, AND S. 05° 00' W., 175 FEET, MORE OR LESS, TO A POINT ON THE ORDINARY HIGH WATER MARK ON THE LEFT BANK OF MIDDLE RIVER, CONTAINING 0.49 ACRE, MORE OR LESS.

APPLICATION FOR APPROVAL OF A SUBMARINE CABLE ACROSS SUBMERGED LANDS OF MIDDLE RIVER BETWEEN UNION ISLAND AND DREXLER TRACT AT THE TRACY ROAD BRIDGE, SAN JOAQUIN COUNTY, THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY - W.O. 3904.

An application has been received from the Pacific Telephone and Telegraph Company for approval of a submarine telephone cable across Middle River between Union Island and Drexler Tract at the Tracy Road Bridge, approximately 4 miles southwest of Holt, San Joaquin County (see Exhibits "A" and "B"). The armored cable is to be buried in the bed of the river. The Department of Public Works of San Joaquin County has expressed no objection to the placement of the cable adjacent to the bridge.

In accordance with Section 7901 of the Public Utilities Code and with Attorney General's Opinion No. 52/56, the Commission previously adopted the "approval-of-location agreement form" to be used for telephone and telegraph facilities crossing State lands. The filing fee and expense deposit have been received. Neither rent nor bond is required.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO EXECUTE AN AGREEMENT WITH THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY, PURSUANT TO THE PROVISIONS OF SECTION 7901 OF THE PUBLIC UTILITIES CODE AND OF ATTORNEY GENERAL'S OPINION 52/56, IN THE FORM PREVIOUSLY ADOPTED BY THE COMMISSION, APPROVING THE LOCATION OF A SUBMARINE CABLE, WITH THE NECESSARY APPURTENANCES, ACROSS THE FOLLOWING-DESCRIBED PORTION OF LAND:

A PARCEL OF TIDE AND SUBMERGED LAND 50 FEET WIDE IN MIDDLE RIVER, BETWEEN DREXLER TRACT AND UNION ISLAND, SAN JOAQUIN COUNTY, APPROXIMATELY 4 MILES SOUTHWESTERLY OF HOLT, LYING 25 FEET ON EITHER SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK ON THE RIGHT BANK OF MIDDLE RIVER WHICH BEARS S. 40° 35' W., 38 FEET, MORE OR LESS, FROM STA. 81 + 68.92 AS SHOWN ON SAN JOAQUIN COUNTY SURVEY NO. 4700, ENTITLED "SURVEY OF TRACY ROAD NO. 923"; THENCE S. 13° 00' E., 250 FEET, MORE OR LESS, AND S. 05° 00' W., 175 FEET, MORE OR LESS, TO A POINT ON THE ORDINARY HIGH WATER MARK ON THE LEFT BANK OF MIDDLE RIVER, CONTAINING 0.49 ACRE, MORE OR LESS.
