After consideration of Calendar Item 9 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OPERATIONS, INC., A GEOLOGICAL SURVEY PERMIT, IN CONFORMANCE WITH REGULATIONS ADOPTED BY THE COMMISSION, FOR THE PERIOD AUGUST 28, 1962, THROUGH FEBRUARY 27, 1963, AUTHORIZING THE CONDUCT OF GEOLOGICAL SURVEYS ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT ARGUELLO, SANTA BARBARA COUNTY, AND THE NORTHERN BOUNDARY OF THE STATE OF CALIFORNIA.

An application has been received from Standard Oil Company of California, Western Operations, Inc., for a geological survey permit covering portions of the tide and submerged lands under the jurisdiction of the State Lands Commission in Santa Barbara, San Luis Obispo, Monterey, Santa Cruz, San Mateo, San Francisco, Marin, Sonoma, Mendocino, Humboldt, and Del Norte Counties.
