

MINUTE ITEM

6. APPLICATION FOR PERMIT TO MAKE TEST BORINGS ON STATE SCHOOL LANDS, INYO COUNTY; U. S. ARMY CORPS OF ENGINEERS - W.O. 4507, P.R.C. 2951.9.

After consideration of Calendar Item 6 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE U. S. ARMY CORPS OF ENGINEERS A ONE-YEAR PERMIT TO MAKE TEST BORINGS ON STATE SCHOOL LANDS DESIGNATED AS THE SW $\frac{1}{4}$ OF THE SW $\frac{1}{4}$ AND LOTS 3, 6, 8, AND 10 OF SECTION 36, T. 25 N., R. 7 E., S.B.B.& M.

THE CONSIDERATION IS TO BE THE INTERESTS OF NATIONAL DEFENSE AND THE FURNISHING TO THE COMMISSION OF A COPY OF THE TEST REPORT BY THE ARMY ENGINEERS.

APPLICATION FOR PERMIT TO MAKE TEST BORINGS ON STATE SCHOOL LANDS, INYO COUNTY; U. S. ARMY CORPS OF ENGINEERS - W.O. 4507.

The U. S. Army Corps of Engineers has applied for a permit to make test borings on State school lands designated as the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ and Lots 3, 6, 8, and 10 of Section 36, T. 25 N., R. 7 E., S.B.B. & M., the area of this land totaling 136.23 acres more or less (see Exhibit "A").

The drilling is to be accomplished by landing small planes with necessary drilling equipment. Each test will take from three to four days, after which the land will be restored to its natural condition. The purpose of the tests is to analyze soil characteristics in the region. A copy of the test report will be furnished the State. All drilling will be in compliance with all rules and regulations now promulgated by any agency of the State of California having jurisdiction therein.

The permit is to be for one year, and the consideration is to be the interests of national defense.
