William and Edith Daley have applied for a lease covering Lot 17 of the Fish Canyon Cabin Sites on State school land north of Duarte, Los Angeles County (see Exhibit "A"), for the construction, maintenance, and use of a recreational cabin.

The lease is to be for a term of 10 years, at an annual rental of \$65, this term and rental having been approved by Commission action for Fish Canyon cabin site leases. The first and last years' rental will be payable in advance.
