## MINUTE ITEM

8. APPLICATION FOR DREDGING PERMIT, SUBMERGED LANDS, SAN JOAQUIN RIVER, CONTRA COSTA COUNTY; PACIFIC GAS AND ELECTRIC COMPANY - W.O. 4649, P.R.C. 2997.1.

After consideration of Calendar Item 6 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO PACIFIC GAS AND ELECTRIC COMPANY A PERMIT TO DREDGE APPROXIMATELY 2,360 CUBIC YARDS OF MATERIAL, AT A ROYALTY OF THREE CENTS PER CUBIC YARD FOR ALL MATERIAL REMOVED, FROM AN AREA OF TIDE AND SUBMERGED LAND IN THE BED OF THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY; SUBJECT TO THE CONDITION THAT NO DREDGING OPERATIONS SHALL BE CONDUCTED IN THE PERMIT AREA ON SATURDAYS, SUNDAYS AND HOLIDAYS. THE AREA TO BE INCLUDED IN THE PERMIT IS DESCRIBED AS FOLLOWS:

A PARCEL OF SUBMERGED LAND IN THE BED OF THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE MOST NORTHERLY CORNER OF THE PARCEL OF LAND DESCRIBED IN THE JUDGMENT AND DECREE QUIETING TITLE TO REAL PROPERTY DATED OCTOBER 15, 1954, AND RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY OF CONTRA COSTA IN BOOK 2399 OF OFFICIAL RECORDS AT PAGE 355, AND RUNNING THENCE SOUTH 73° 05' WEST, ALONG THE NORTHERLY BOUNDARY LINE OF SAID PARCEL, A DISTANCE OF 75 FEET; THENCE NORTH 4° 55' WEST, 43 FEET; THENCE NORTH 22° 05' EAST, 54 FEET; THENCE MORTH 81° 30' EAST, 46 FEET; THENCE SOUTH 73° 00' EAST, 56 FEET; THENCE SOUTH 54° 42' EAST, 60.37 FEET; THENCE SOUTH 33° 57' EAST, 53 FEET TO THE AFOREMENTIONED NORTHERLY BOUNDARY LINE; THENCE ALONG SAME NORTH 81° 57' WEST', 124 FEET TO THE POINT OF BEGINNING, CONTAINING 0.28 ACRE MORE OR LESS.

## CALENDAR ITEM

6.

APPLICATION FOR DREDGING PERMIT, SUBMERGED LANDS, SAN JOAQUIN RIVER, CONTRA COSTA COUNTY; PACIFIC GAS AND ELECTRIC COMPANY - W.O. 4649.

An application has been received from the Pacific Gas and Electric Company for a permit to dredge approximately 2.360 cubic yards of fill material from an area of submerged lands in the bed of the San Joaquin River adjacent to Pacific Gas and Electric Company's Antioch Power Plant, Contra Costa County, for the purpose of creating a water-intake channel. The material extracted is to be deposited on property owned by Pacific Gas and Electric Company.

Sections 6303 and 6321 of the Public Resources Code provide that "The Commission may grant the privilege of...extracting material from...tide and submerged lands...for purposes connected with the erection or maintenance of structures...upon such terms and conditions and for such consideration as will be in the best interest of this State,...upon written application of the littoral owner,...if, at the time of the construction,...such structures do not unreasonably interfere with the uses and purposes reserved to the people of the State."

The U. S. Corps of Engineers has issued a permit authorizing the conduct of dredging operations at the location described in the application; the Division of Beaches and Parks has reported that the proposed operations will not interfere with the recreational use of the lands littoral to the tide and submerged lands involved in the application.

The Department of Fish and Game has recommended that to reduce any conflict with the sports fishing, dredging should be prohibited on Saturdays Sundays and holidays.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO PACIFIC GAS AND ELECTRIC COMPANY A PERMIT TO DREDGE APPROXIMATELY 2,360 CUBIC YARDS OF MATERIAL, AT A ROYALTY OF THREE CENTS PER CUBIC YARD FOR ALL MATERIAL REMOVED, FROM AN AREA OF TIDE AND SUBMERGED LAND IN THE BED OF THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY; SUBJECT TO THE CONDITION THAT NO DREDGING OPERATIONS SHALL BE CONDUCTED IN THE PERMIT AREA ON SATURDAYS, SUNDAYS AND HOLIDAYS. THE AREA TO BE INCLUDED IN THE FERMIT IS DESCRIBED AS FOLLOWS:

A PARCEL OF SUBMERGED LAND IN THE BED OF THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE MOST NORTHERLY CORNER OF THE PARCEL OF LAND DESCRIBED IN THE JUDGMENT AND DECREE QUIETING TITLE TO REAL PROPERTY DATED OCTOBER 15, 1954, AND RECORDED IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY OF CONTRA COSTA IN BOOK 2399 OF OFFICIAL RECORDS AT PAGE 396, AND RUNNING THENCE SOUTH 73° O5 WEST, ALONG THE NORTHERLY BOUNDARY LINE OF SAID PARCEL, A DISTANCE OF 75 FEET; THENCE NORTH 4° 55' WEST, 43 FEET; THENCE NORTH 22° O5' EAST, 54 FEET; THENCE NORTH 81° 30' EAST, 46 FIET; THENCE SOUTH 73° OO' EAST, 56 FEET; THENCE SOUTH 54° 42' EAST, 60.37 FEET; THENCE SOUTH 33° 57' EAST, 53 FEET TO THE AFORMMENTIONED NORTHERLY BOUNDARY LINE; THENCE ALONG SALE WORTH 81° 57' WEST, 124 FEET TO THE POINT OF BEGINNING, CONTAINING 0.28 ACRE MORE OR LESS.
