

MINUTE ITEM

13. APPLICATION FOR AMENDMENT OF EASEMENT P.R.C. 2932.1, COVERING TIDE AND SUBMERGED LANDS OF SANTA BARBARA CHANNEL, SANTA BARBARA COUNTY; RICHFIELD OIL CORPORATION - W.O. 4699.

After consideration of Calendar Item 13 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO RICHFIELD OIL CORPORATION AN AMENDMENT OF THE LEGAL DESCRIPTION OF EASEMENT P.R.C. 2932.1; THE DESCRIPTION ON PAGE ONE OF SAID EASEMENT IS TO BE ENTIRELY DELETED AND THE FOLLOWING SUBSTITUTED IN LIEU THEREOF:

A STRIP OF TIDE AND SUBMERGED LAND 30 FEET IN WIDTH IN THE SANTA BARBARA CHANNEL AT GAVIOTA, CALIFORNIA; THE CENTERLINE BEING DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE MEAN HIGH TIDE LINE OF THE SANTA BARBARA CHANNEL, WHICH POINT HAS ZONE 5 CALIFORNIA COORDINATES OF X = 1,335,468.00 FEET AND Y = 360,462.00 FEET; THENCE ALONG THE FOLLOWING COURSES:

APPLICATION FOR AMENDMENT OF EASEMENT P.R.C. 2932.1, COVERING TIDE AND SUBMERGED LANDS OF SANTA BARBARA CHANNEL, SANTA BARBARA COUNTY; RICHFIELD OIL CORPORATION - W.O. 4699.

Easement P.R.C. 2932.1, covering 11.688 acres more or less of tide and submerged lands of Santa Barbara Channel, Santa Barbara County, was issued to Richfield Oil Corporation on September 12, 1962, for a period of 49 years for a pipe line from well completion 2793 No. 1 to shore.

The line is now completed and the applicant has applied for an amendment of the legal description of the easement to conform with the position of the line as installed (see Exhibit "A").

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO RICHFIELD OIL CORPORATION AN AMENDMENT OF THE LEGAL DESCRIPTION OF EASEMENT P.R.C. 2932.1; THE DESCRIPTION ON PAGE ONE OF SAID EASEMENT IS TO BE ENTIRELY DELETED AND THE FOLLOWING SUBSTITUTED IN LIEU THEREOF:
