THE COMMISSION APPROVES THE USE OF THE REVISED DESCRIPTION OF THE AREA INCLUDED IN W.O. 4670 (PARCEL 13), WHICH READS AS FOLLOWS:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK OF THE SANTA BARBARA CHANNEL AT THE INTERSECTION WITH THE EAST EXCEPTION LINE AS SPECIFIED IN SECTION 6871.2(b) PUBLIC RESOURCES CODE; THENCE FROM SAID POINT OF BEGINNING SOUTH (GEOGRAPHIC) ALONG SAID EAST EXCEPTION LINE 3,808.19 FEET MORE OR LESS TO CALIFORNIA COORDINATE SYSTEM, ZONE 5, Y COORDINATE = 334,860; THENCE EASTERLY 7,000 FEET TO A POINT ALONG THE LINE HAVING A CALIFORNIA COORDINATE SYSTEM, ZONE 5, Y COORDINATE = 354,860; THENCE WORTH (GEOGRAPHIC) 1,900.36 FEET MORE OR LESS TO THE ORDINARY HIGH WATER MARK; THENCE WESTERLY ALONG THE ORDINARY HIGH WATER MARK TO THE POINT OF BEGINNING; CONTAINING 505.36 ACRES MORE OR LESS.

## CALENDAR ITEM

REVISED DESCRIPTION, PROPOSED OIL AND GAS LEASE, TIDE AND SURMERGED LANDS, SANTA BARBARA COUNTY - W.O. 4670 (PARCEL 13).

On February 28, 1963, the Commission authorized the Executive Officer to offer a parcel of tide and submerged lands (Parcel 13) in Santa Barbara County for oil and gas lease pursuant to Division 6 of the Public Resources Code. The parcel was described as follows:

Beginning at 1 point on the ordinary high water mark of the Santa Barbara Channel at the intersection with the east exception line as specified in Section 6871.2(b) Public Resources Code; thence from said point of beginning south (geographic) along said east exception line approximately 3,700 feet to California Coordinate System, Zone 3, Y coordinate = 334,860; thence easterly 7,000 feet to a point along the line having a California Coordinate System, Zone 5, Y coordinate = 334,860; thence north (geographic) approximately 1,970 feet to the ordinary high water mark; thence westerly along the ordinary high water mark to the point of beginning; containing approximately 500 acres.

From a further review, revision of the area description has been found to be desirable.

IT IS RECOMMENDED THAT THE COMMISSION APPROVE THE USE OF THE REVISED DESCRIPTION OF THE AREA INCLUDED IN W.O. 4670 (PARCEL 13), WHICH READS AS FOLLOWS:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK OF THE SANTA BARBARA CHANNEL AT THE INTERSECTION WITH THE EAST EXCEPTION LINE AS SPECIFIED IN SECTION 6871.2(b) PUBLIC RESOURCES COPE; THENCE FROM SAID POINT OF BEGINNING SOUTH (GEOGRAPHIC) ALONG SAID EAST EXCEPTION LINE 3,808.19 FEET MORE OR LESS TO CALIFORNIA COORDINATE SYSTEM, ZONE 5, Y COORDINATE = 334,860; THENCE EASTERLY 7,000 FEET TO A POINT ALONG THE LINE HAVING A CALIFORNIA COORDINATE SYSTEM, ZONE 5, Y COORDINATE = 334,860; THENCE NORTH (GEOGRAPHIC) 1,500.36 FEET MORE OR LESS TO THE ORDINARY HIGH WATER MARK TO THE POINT OF BEGINNING; CONTAINING 505.36 ACRES MORE OR LESS.
