The Crescent City Harbor District, lessee of tide and submerged land in Crescent City Bay under Lease P.R.C. 502.1, which terminates in 1984, at an escalated rental (presently \$500 annually), has submitted for approval, as required by terms of the lease, a subleate to Charles W. Howe of a small portion (approximately 5000 square feet) of the leased site for the operation of a business for the sale of marine supplies, fishing gear, curios, and for the operation of a restaurant and allied facilities. The sublease is for a term of 10 years commencing May 1, 1963, at a monthly rental of \$32.50. Staff Counsel has reviewed the form of the sublease and has found it to be legally sufficient.
