APPLICATION FOR APPROVAL OF SUBLEASE UNDER LEASE P.R.C. 2364.2, STATE SCHOOL LANDS IN SECTION 36, T. 1 N., R. 1 W., M.D.B.& M., CONTRA COSTA COUNTY; LINDSEY H. SPIGHT - W.O. 4614.

Lease P.R.C. 2364.2, covering Lot 4 and the W_2^1 of Lot 2, Section 36, T. 1 N., R. 1 W., M.D.B.& M., on Mt. Diablo in Contra Costa County, was issued to Lindsey H. Spight, d.b.a. Diablo Communications Center, for 15 years beginning March 16, 1959, at an annual rental of \$1,098, with provision for two renewal periods of 10 years each. The lessee is authorized to sublease, subject to prior approval by the Commission.

An application has been received for approval of a sublease to Metromedia, Inc., for a portion of the leased site sufficient for the installation, maintenance, and operation of a mobile repeater transmitting on 461.350 mc and receiving on 468.300 mc. The sublease is to run for an indefinite period not to exceed the term of Lease P.R.C. 2364.2, at a monthly rental of \$100.

The Communications Division of the Department of Finance has reported that there is no objection to the proposed installation.
