14. APPLICATION FOR ASSIGNMENT OF LEASE P.R.C. 2987.2, COVERING STATE SCHOOL LANDS OF FISH CANYON, LOS ANGELES COUNTY; A. BRUCE KUTCHER - W.O. 4714.
