

MINUTE ITEM

7. APPLICATION FOR EXTENSION OF TERM OF PERMIT P.R.C. 2585.9, TIDE AND SUBMERGED LANDS OF SACRAMENTO RIVER, CONTRA COSTA AND SOLANO COUNTIES; DEPARTMENT OF WATER RESOURCES - W.O. 4781.

After consideration of Calendar Item 31 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE DEPARTMENT OF WATER RESOURCES AN EXTENSION OF THE TERM OF PERMIT P.R.C. 2585.9 TO JUNE 30, 1964; ALL OTHER TERMS AND CONDITIONS OF SAID PERMIT ARE TO REMAIN IN FULL FORCE AND EFFECT. THE CONSIDERATION FOR THIS EXTENSION IS TO BE THE PUBLIC BENEFIT.

APPLICATION FOR EXTENSION OF TERM OF PERMIT P.R.C. 2585.9, TIDE AND SUBMERGED LANDS OF SACRAMENTO RIVER, CONTRA COSTA AND SOLANO COUNTIES; DEPARTMENT OF WATER RESOURCES - W.O. 4781.

Permit P.R.C. 2585.9 was issued to the Department of Water Resources on June 1, 1960 for a period of three years, and was amended on July 28, 1961, to increase the permit area to 63 acres more or less of tide and submerged lands of the Sacramento River between Chipps and Mallard Islands, downstream from Pittsburg, Contra Costa and Solano Counties (see Exhibit "A").

The permit was for the installation of current meters, to be used in developing and proving methods of obtaining a continuous record of current velocities, and in measuring the net outflow of water from the Sacramento-San Joaquin Delta.

The applicant has requested an extension of the term of said permit to June 30, 1964; all other terms and conditions of Permit P.R.C. 2585.9 are to remain in full force and effect.

The consideration for the extension of the permit is to be the public benefit.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE DEPARTMENT OF WATER RESOURCES AN EXTENSION OF THE TERM OF PERMIT P.R.C. 2585.9 TO JUNE 30, 1964; ALL OTHER TERMS AND CONDITIONS OF SAID PERMIT ARE TO REMAIN IN FULL FORCE AND EFFECT.
