ASSIGNMENT OF GRAZING LEASE P.R.C. 2985.2, SAN BERNARDINO COUNTY; KENNETH E. EDMISTON AND MARJORIE A. EDMISTON TO BILL CLEVERLY AND JUNE W. CLEVERLY - S.W.O. 7908.

Grazing Lease P.R.C. 2985.2 was issued on May 29, 1963, to Kenneth E. and Marjorie A. Edmiston of Scottsdale, Arizona, for Section 36, T. 3 N., R. 18 E.; Section 16, T. 3 N., R. 19 E.; Section 16, T. 7 N., R. 17 E.; Section 36, T. 8 N., R. 17 E.; Section 16, T. 8 N., R. 18 E.; and Section 16, T. 8 N., R. 19 E., all S.B.M., containing 3,840 acres in San Bernardino County, for a period of five years commencing April 1, 1963, and ending March 31, 1968, at an annual rental of \$38.40.

The Lessees propose to assign the lease, and an assignment form, executed by Kenneth E. Edmiston and Marjorie A. Edmiston, was accepted by the Bill Cleverly and June W. Cleverly on May 3, 1963.

The lease provides that the lessees shall not transfer or assign the lease except upon the prior written consent of the State.

The statutory filing fee of \$5.00 has been paid.
