After consideration of Calendar Item 22 attached, and upor motion duly made and unanimously carried, the following resolution was adopted:

APPLICATION FOR PERMIT TO DREDGE IN CARQUINEZ STRAIT, CONTRA COSTA COUNTY; AMERICAN SMELTING AND REFINING COMPANY - W.O. 4838.

An application has been received from American Smelting and Refining Company for a pendt to dredge approximately 15,000 cubic yards of material from State-owned tide and submerged lands in Carquinez Strait adjacent to the applicant's wharf at Selby (see Exhibit "A"). The wharf location is authorized by Lease P.R.C. 618.1. To provide sufficient depth of water at the Selby wharf to accommodate ocean-going vessels, similar permits were previously authorized in 1954, 1956, 1957, 1958 and 1961. The dredged material is to be deposited in deep water in Carquinez Strait, as authorized by the U. S. Army Corps of Engineers.

Consideration for the issuance of the permit is to be the benefit to navigation. The filing fee has been paid.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO AMERICAN SMELTING AND REFININ COMPANY A PERMIT TO DREDGE APPROXIMATELY 15,000 CUBIC YARDS OF MATERIAL FROM STATE-OWNED TIDE AND SUBMERSED LANDS IN CAROUINEZ STRAIT, CONTRA COSTA COUNTY, ADJACENT TO APPLICANT'S WHARF, AND TO DEPOSIT THE DREDGED MATERIAL IN DEEP WATER OF THE STRAIT, THE CONSIDERATION FOR ISSUANCE OF THE PERMIT TO BE THE BENEFIT TO NAVIGATION.
