4. MCDIFICATION OF DREDGING PERMIT, SAU DIEGO BAY, SAN DIEGO COUNTY; SAN DIEGO GAS AND ELECTRIC COMPANY - W.O. 4814, P.R.C. 2960.9.

After consideration of Calendar Item 3 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO APPROVE THE EXTRACTION BY THE SAN DIEGO GAS AND ELECTRIC COMPANY WITHOUT THE PAYMENT OF ROYALTY, OF AN ADDITIONAL 63,000 CUBIC YARDS OF MATERIAL FOR THE CONSTRUCTION OF A DIKE. THE MATERIAL IS TO BE DREDGED FROM AND REDEPOSITED ON ADJACENT TIDE AND SURMERGED LANDS WITHIN THE GRANT TO THE CITY OF CHULA VISTA IN THE AREA COVERED BY DREDGING PERMIT P.R.C. 2960.9.

ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN IN FULL FORCE AND EFFECT.

MODIFICATION OF LALDGING PERMIT, SAN DIEGO BAY, SAN DIEGO COUNTY; SAN DIEGO GAS AND ELECTRIC COMPANY - W.O. 4814, P.R.C. 2960.9.

On December 6, 1962 (Minute Item 8, page 8426), the State Lands Commission authorized San Diego Gas and Electric Company to dredge during the period December 6, 1962, through December 31, 1963, without payment of royalty, approximately 102,782 cubic yards of material from certain tide and submerged lands in San Diego Bay, San Diego County, for the construction of a dike on tide and submerged lands adjacent to the extraction area. Records of this Division indicate that as of March 31, 1963, a total of 107,000 cutic yards had been moved.

An application has been submitted by the San Diego Gas and Electric Company, requesting authorization for the removal of an additional 63,000 cubic yards of material, or a total of 170,000 cubic yards, for the project.

According to the applicant, the fluid character of material used for the dike construction resulted in failure of all dredged material to remain in place; therefore, their original estimate was too low. It is now estimated that an additional 63,000 cubic yards will be required to complete the project. The additional material is to be moved from within the permit area as approved originally.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO APPROVE THE EXTRACTION BY THE SAN DIEGO GAS AND ELECTRIC COMPANY WITHOUT THE PAYMENT OF ROYALTY, OF AN ADDITIONAL 63,000 CUBIC YARDS OF MATERIAL FOR THE CONSTRUCTION OF A DIKE. THE MATERIAL IS TO BE OREDGED FROM AND PEDEPOSITED ON ADJACENT TIDE AND SUBMERGED LANDS WITHIN T. GRANT TO THE CITY OF CHULA VISTA IN THE AREA COVERED BY DREDGING PERMIT P.R.C. 2960.9.

ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN IN FULL FORCE AND EFFECT.
