4. APPLICATION FOR APPROVAL OF LOCATION OF OVERHEAD TELEPHONE CABLE ACROSS THE COLORADO RIVER, SAN BERNARDINO COUNTY; THE PARKER VALLEY TELEPHONE COMPANY, INC. - W.O. 4866, P.R.C. 3059.9.

After consideration of Calendar Item 6 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXECUTE AN AGREEMENT WITH THE PARKER VALLEY TELEPHONE COMPANY, INC., PURSUANT TO THE PROVISIONS OF SECTION 7901 OF THE PUBLIC UTILITIES CODE AND OF ATTORNEY GENERAL'S OPINION NO. 52/56, IN THE FORM PREVIOUSLY ADOPTED BY THE COMMISSION, APPROVING THE LOCATION OF AN OVERHEAD TELEPHONE CABLE WITH THE NECESSARY APPURTENANCES, ACROSS THE UNGRANTED TIDE AND SUBMERGED LANDS OF THE COLORADO RIVER IN SECTION 10, T. 1 N., R. 26 E., S.B.B. & M., REFERRED TO AS PARCEL "A", AND AS SHOWN ON MAP FILED IN THE OFFICE OF THE STATE LANDS DIVISION.

APPLICATION FOR APPROVAL OF LOCATION OF OVERHEAD TELEPHONE CABLE ACROSS THE COLORADO RIVER, SAN BERNARDINO COUNTY; THE PARKER VALLEY TELEPHONE COMPANY, INC. - W.O. 4866.

An application has been received from The Parker Valley Telephone Company, Inc., for approval of the location of an overhead telephone cable crossing ungranted tide and submerged lands of the Colorado River out to the thread of the river within the Colorado Indian Reservation in San Bernardino County, California, $3\frac{1}{2}$ miles upstream and across from Yuma County, Parker, Arizona (see Parcel "A", Exhibits "A" and "B"), in Section 10, T. 1 N., R. 26 E., S.B.B. & M.

The proposed crossing, 10 feet wide and approximately 510 feet long, is to be suspended with a minimum overhead clearance of 38 feet.

The Commission previously adopted an "Approval-of-Location Agreement Form" to be used for telephone and telegraph facilities crossing State lands, in accordance with Section 7901 of the Public Utilities Code and with Attorney General's Opinion No. 52/56.
