MINUTE ITEM

11. APPLICATION FOR A PERMIT TO CONDUCT SUBMARINE GEOPHYSICAL OPERATIONS, MENDOCINO, SONOMA, MARIN, SAN FRANCISCO, SAN MATEO, SANTA CRUZ, MONTEREY, SAN LUIS OBISPO, SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE AND SAN DIEGO COUNTIES; HUMBLE OIL & REFINING COMPANY - W.O. 4976, P.R.C. 3092.1.

After consideration of Calentar Item 23 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO HUMBLE OIL & REFINING COMPANY A GEOPHYSICAL EXPLORATION PERMIT IN THE FORM APPROVED BY THE STATE LANDS COMMISSION IN CALENDAR ITEM NO. 21 (W.O. 4961) OF THIS AGENDA, FOR THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION WHICH ARE SHOREWARD OF THE "OPERATIONS LINE" APPROVED DECEMBER 6, 1962 (MINUTE ITEM 29, PAGE 8454), IN THE AREAS DESCRIBED AS FOLLOWS:

- A. LYING BETWEEN A LINE FORMING THE NORTHERN BOUNDARY OF MENDOCINO COUNTY AND THE SEAWARD EXTENSION THEREOF, AND THE SEAWARD EXTENSION OF A LINE DRAWN DUE SOUTH FROM A POINT ON THE MFATT AIGH TIDE LINE OF THE SANTA BARBARA CHANNEL HAVING ZONE 5 CALIFORNIA COORDINATES OF X = 1,441,189.36 FEET AND Y = 335,615.67 FEET (EXCLUDING SAN FRANCISCO BAY AND OTHER INLAND WATERS DRAINING THEREIM).
- B. LYING BETWEEN THE SEAWARD EXTENSION OF A LINE DRAWN DUE SOUTH FROM A POINT ON TH' MEAN HIGH TIDE LINE OF THE SANTA BARBARA CHANNEL HAVING ZONE 5 CALIFORNIA COORDINATES OF X = 1,515,471.78 FEET AND Y = 538,667.70 FEET, AND A LINE FORMING THE NORTHWESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH AND THE SEAWARD EXTENSION THEREOF.
- C. ING BETWEEN THE EASTERLY BOUNDARY OF PARCEL A ABOVE AND THE WESTERLY UNDARY OF PARCEL B ABOVE, AND BEING ALSO SEAWARD OF A LINE LOCATED TREE NAUTICAL MILES SEAWARD FROM THE MEAN HIGH TIDE LINE OF THE SANTA MARBARA CHANNEL.
- D LYING BETWEEN A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF, AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.
- E. TO BETWEEN THE SOUTHEASTERLY BOUNDARY OF PARCEL B AND THE NORTH-LOCATED THREE NAUTICAL MILES SEAWARD FROM THE MEAN HIGH TIDE LINE OF THE GULF OF SANTA CATALINA.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM FEBRUARY 1, 1964 THROUGH JULY 31, 1964.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ALL OF ITS INSPECTION COSTS.

THE PERMIT IS TO BE EFFECTIVE ONLY AS LONG AS A CONCURRENT PERMIT BY THE FISH AND GAME COMMISSION IS IN EFFECT FOR THE SAME OPERATING AREA.

APPLICATION FOR A PERMIT TO CONDUCT SUBMARINE GEOPHYSICAL OPERATIONS, MENDOCINO, SONOMA, MARIN, SAN FRANCISCO, SAN MATEO, SANTA CRUZ, MONTEREY, SAN LUIS OBISPO, SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE AND SAN DIEGO COUNTIES; HUMBLE OIL & REFINING COMPANY - W.O. 4976.

An application has been received from Humble Oil & Refining Company for a permit to conduct submarine seismic exploration operations in the area lying shoreward of the "operations line" between the northern and southern boundaries of the State of California, during the period February 1, 1964 through July 31, 1964.

The Boards of Supervisors of the Counties of Mendocino, Sonoma, Marin, San Francisco, San Mateo, Santa Cruz, Monterey, San Luis Obispo, Santa Barbara, Ventura, Los Angeles, Orange and San Diego, the Mayor and the City Council of the City of Santa Barbara, and the Greater Santa Cruz Chamber of Commerce have been informed that this application is to be considered. Because of a request from the Board of Supervisors of Humboldt County, submitted on behalf of commercial and sport fishermen of Humboldt and Del Norte Counties, that no seismic operations be authorized offshore those counties, current Commission practice has been to exclude the area offshore Humboldt and Del Norte Counties from seismic permits.

The statutory filing fee has been paid by the applicant.

Humble Oil & Refining Company also has submitted an application to the Department of Fish and Game for the conduct of seismic operations covering the above-described area.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO LOUIS TO HUMBLE OIL & REFINING COMPANY A GEOPHYSICAL EXPLORATION PERMIT IN THE FORM APPROVED BY THE STATE LANDS COMMISSION IN CALENDAR ITEM NO. 21 (1.0. 4961) OF THIS AGENDA, FOR THOSE TIDE AND SUBMERGED LANDS UNDER THE JULY DICTION OF THE STATE LANDS COMMISSION WHICH ARE SHOREWARD OF THE "Operations line" Approved December 6, 1962 (MINUTE ITEM 29, PAGE 8454), IN THE AREAS DESCRIBED AS FOLLOWS:

LYING BETWEEN THE SEAWARD EXTENSION OF A LINE DRAWN DUE SOUTH FROM A POINT ON THE MEAN HIGH TIDE LINE OF THE SANTA BARBARA CHANNEL HAVING ZONE 5 CALIFORNIA COORDINATES OF X=1,515,471.78 FEET AND Y=338,667.70 FEET, AND A LINE FORMING THE NORTHWESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH AND THE SEAWARD EXTENSION THEREOF.

- C. LYING BETWEEN THE EASTERLY BOUNDARY OF PARCEL A ABOVE AND THE WESTERLY BOUNT BY OF PARCEL B ABOVE, AND BEING ALSO SEAWARD OF A LINE LOCATED THREE DUTICAL MILES SEAWARD FROM THE MEAN HIGH TIDE LINE OF THE SANTA BARBARA CHANNEL.
- D. LYING BETWEEN A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF, AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.
- E. LYING BETWEEN THE SOUTHEASTERLY BOUNDARY OF PARCEL B AND THE NORTHWESTERLY BOUNDARY OF PARCEL D, AND BEING ALSO SEAWARD OF A LINE LOCATED THREE NAUTICAL MILES SEAWARD FROM THE MEAN HIGH TIDE LINE OF THE GULF OF SANTA CATALINA.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM FEBRUARY 1, 1964 THROUGH JULY 31, 1964.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ALL OF ITS INSPECTION COSTS.

THE PERMIT IS TO BE EFFECTIVE ONLY AS LONG AS A CONCURRENT PERMIT BY THE FISH AND GAME COMMISSION IS IN EFFECT FOR THE SAME OPERATING AREA.
