13. APPLICATION FOR GEOLOGICAL SURVEY PERMIT; ORANGE AND SAN DIEGO COUNTIES; STANDARD OIL COMPANY OF CALIFORNIA - W.O. 5067, P.R.C. 3115.1.

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO STA. ARD OIL COMPANY OF CALIFORNIA A GEOLOGICAL SURVEY PERMIT, IN CONFORMANCE WITH REGULATIONS ADOPTED BY THE COMMISSION, FOR THE PERIOD MARCH 26, 1964, TO SEPTEMBER 25, 1964, INCLUSIVE, AUTHORIZING THE CONDUCT OF GEOLOGICAL SURVEYS ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION WHICH ARE SHOREWARD OF THE "OPERATIONS LINE" APPROVED DECEMBER 6, 1962 (MINUTE ITEM 29, PAGE 8485), IN THE AREA:

- A. LYING BETWEEN A LINE FORMING THE SOUTHEASTERLY BOUNDARY OF ORANGE COUNTY AND THE SEAWARD EXTENSION THEREOF, AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.
- B. LYING BETWEEN A LINE FORMING THE NORTHWESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH AND THE SEAWARD EXTENSION THEREOY, AND THE NORTHWESTERLY BOUNDARY OF PARCEL A, AND BEING ALSO SEAWARD OF A LINE LOCATED THREE NAUTICAL MILES SEAWARD FROM THE MEAN HIGH TIDE LINE OF THE GULF OF SANTA CATALINA.

APPLICATION FOR GEOLOGICAL SURVEY PERMIT; ORANGE AND SAN DIEGO COUNTIES; STANDARD OIL COMPANY OF CALIFORNIA - W.O. 5067.

An application has been received from Standard Oil Company of California for a geological survey permit covering portions of the tide and submerged lands under the jurisdiction of the State Lands Commission in Orange and San Diego Counties, for the six-month period commencing March 26, 1964.

- B. LYING BETWEEN A LINE FORMING THE NORTHWESTERLY BOUNDARY OF THE CITY OF NEWPORT BEACH AND THE SEAWARD EXTENSION THEREOF, AND THE NORTHWESTERLY BOUNDARY OF PARCEL A, AND BEING ALSO SEAWARD OF A LINE LOCATED THREE NAUTICAL MILES SEAWARD FROM THE LEAN HIGH TIDE LINE OF THE GULF OF SANTA CATALINA.
