4. APPLICATION FOR LIFE-OF-STRUCTURE PERMIT FON A LAUNCHING RAMP FACILITY AND LOG BOOM IN SACRAMENTO RIVER, CITY OF REDDING; SHASTA COUNTY - W.O. 5073, P.R.C. 3122.9.

APPLICATION FOR LIFE-OF-STRUCTURE FERMIT FOR A LAUNCHING RAMP FACILITY AND LOG BOOM IN SACRAMENTO RIVER, CITY OF REDDING; SHASTA COUNTY -W.O. 5073.

An application has been received from the City of Redding, Shasta County, for a 40-year life-of-structure permit for the construction of a smallcraft launching facility and a protective log boom in the Sacramento River at Lake Redding Park (see Exhibit "A"). The State Division of Small Craft Harbors is assisting the City of Redding in the financing of the project.

The Launching ramp, to be operated by the Recreation Department of the City of Redding, will be for the use of the boating public.

The log boom across the river is a safety device to prevent small craft from drifting over a weir. The river in this area is referred to as Lake Redding, as the result of the erection of a series of dams to regulate the flow of its waters.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE CITY OF REDDING, SHASTA COUNTY, A 40-YEAR LIFE-OF-STRUCTURE PERMIT FOR THE CONSTRUCTION, OPERATION, AND MAINTENANCE OF A BOAT-LAUNCHING RAMP AND A LOG BOOM ON SOVEREIGN LANDS OF THE SACRAMENTO RIVER, THE CONSIDERATION TO BE THE FUBLIC BENEFIT.
