MINUTE ITEM

32. PROPOSED JIL AND GAS LEASE, SANTA BARBARA COUNTY - W.O. 5110 (PARCEL 21).

After consideration of Calendar Item 32 attached, and upon motion duly made and carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO OFFER A PARCEL OF TIDE AND SUBMERGED LANDS IN SANTA BARBARA COUNTY, DESIGNATED AS W.O. 5110 (PARCEL 21), FOR OIL AND GAS LEASE, PURSUANT TO DIVISION 6 OF THE PUBLIC RESOURCES CODE.

THE LEASE AWARD IS TO BE MADE TO THE QUALIFIED BIDDER OFFERING THE HIGHEST CASH-BONUS PAYMENT.

THE COMBINED BID-LEASE FORM TO BE USED FOR THE PARCEL SHALL BE THE AMENDED FORM APPROVED AND ADOPTED BY THE COMMISSION IN CALENDAR ITEM 22 ON THE FEBRUARY 26, 1964, AGENDA.

THE AREA PROPOSED TO BE OFFERED IS DESCRIBED AS FOLLOWS:

TO AN INTER-SECTION WITH THE MEAN HIGH TIDE LINE; THENCE NORTHWESTERLY ALONG THE MEAN HIGH TIDE LINE TO THE POINT OF BEGINNING; SAID PARCEL CONTAINING 5,553 ACRES MORE OR LESS.

THE BEARINGS AND DISTANCES USED IN THE ABOVE DESCRIPTION AFE BASED ON THE CALIFORNIA COORDINATE SYSTEM ZONE 5.
