After consideration of Calendar Item 34 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO SHELL OIL COMPANY A TEMPOPARY RIGHT-OF-WAY PERMIT FOR A DREDGE PIPE-LINE EASEMENT OVER STATE LANDS FOR TRANSPORTING DREDGED MATERIAL TO A SPOILS AREA ON LAND OF THE UTAH CONSTRUCTION COMPANY, THE PERMIT TO BE IN EFFECT FROM JUNE 1, 1964, TO DECEMBER 31, 1964. CONSIDERATION FOR GRANTING THE EASEMENT IS TO BE THE PUBLIC BENEFIT FROM THE IMPROVEMENT OF COMMERCE AND NAVIGATION.
