An application has been received from Grant W. Squire of Corcoran, California, for a grazing lease, for a term of five years, covering Lots 10, 11, 19, 20, and N_2^1 of SW_4^1 of Section 36, T. 18 S., R. 12 E., M.D.M., containing 187.41 acres in Fresno County.

An appraisal by the staff on April 13, 1964, indicates the fair grazing rental value to be \$0.25 per acre per year, or a total of \$46.85 per year.

THE PROPERTY

Location: It is four miles south to the Los Gatos county road and 26 miles

south to Coalinga.

A:cess: Poor. Four miles north from Los Gatos county road via private

road behind locked gates.

Cover: Grass and brush.

Water: There are several springs on the tract.

Minerals: This area is currently leased to the Mineral Materials Company

by the State of California and subleased to Atlas Corporation under P.R.C.'s 2810 and 2811 for the purpose of extracting all minerals other than oil and gas.

The \$5 filing fee, the necessary deposit to defray appraisal expenses, and \$93.70 for the first and fifth years' rentals, at the rate of \$46.85 per year, have been submitted.
