WHEREAS, the ordinary low water mark as it may have existed in its last natural state has been affected by artificial and natural processes or a combination of both; and

WHEREAS, the State Lands Commission and the Second Party consider it expedient and necessary and in the best interests of the State and the public to describe and fix permanently the ordinary low water mark as the boundary between the lands belonging to the State and Second Party and forever set at rest any and all questions relating to the location of said ordinary low water mark.

NOW, THEREFORE, in order to locate, describe and permanently establish the ordinary low water mark as the true and correct boundary line between the State and Second Party, it is agreed that said boundary line is and shall be located and established as follows:

Commencing at the most Westerly corner of the land described in the Quitclaim Deed to Sam Arvanitis and George Arvanitis, recorded January 20, 1953, in Book 2439, page 488, Official Records, in the Office of the Orange County recorder, being also a point in the Southwesterly line of Tide Land Location No. 141, recorded in Book 1, page 194 of Patents of said Orange County as shown on Record of Survey Map recorded July 17, 1963, in Book 65, page 28 of Maps, Records of Orange County, and also having California Coordinates, Zone 6, N572,059.30 and E1,444,106.82; thence N. 46° 32' 00" E. 208.25 feet to a point on the northeasterly line of Tideland Location No. 141; thence S. 44° 15' 00" E. 77.58 feet and S. 73° 45' 00" Z. 110.76 feet to a point on the northerly line of TTL 141 which point is the True Point of Beginning of this Boundary Line and which is shown on Record of Survey Map filed in Book 53, page 28 of Maps, Records of Orange County; thence, irom said True Point of Beginning, S. 73° 45' 00" E. 495.76 feet to the end of this boundary line.

APPROVAL OF BOUIDARY AGREEMENT BETWEEN STATE OF CALIFORNIA AND BANK OF AMERICA NATIONAL TRUST & SAVINGS ASSOCIATION AS SPECIAL ADMINISTRATOR WITH GENERAL POWERS OF THE ESTATE OF SAM ARVANITIS, DECEASED, ALONG WATERWARD BOUNDARY OF PORTION OF TIDELAND LOCATION NO. 141, VICINITY OF SURFSIDE, ORANGE COUNTY, CALIFORNIA - W.O. 5171.

A tidal waterway in the vicinity of Surfside, Orange County, has been subjected to artificial influences in the interests of navigation. Tideland Location No. 141 lies within this area of influence, but its present waterward boundary is still reasonably representative of the mean low water line of the original Tideland Survey. Record of Survey Map, filed in Book 53, page 28 of Records of Surveys, County of Orange, shows this waterward boundary, which is agreeable to all parties as a permanent boundary. It is proposed to enter into an agreement with Bank of America National Trust & Savings Association to fix the common property boundary along a portion of the waterward line of Tide Land Lot No. 141 as it is shown on said Record of Survey map (Exhibit "B").

The office of the Attorney General previously approved boundary agreements in the subject form; Staff Counsel has determined that the agreement is legally sufficient.
