Exempt Pay Memorandum No. 914, issued by the Department of Finance in January 1964, revised the salary range for the position of Executive Officer from \$1225-\$1490 to \$1351-\$1642 effective January 1, 1964. The appropriation provided to pay the salary increases of exempt classes was insufficient. Therefore, the new salary ranges were considered effective for the January and February pay periods only. At its 1964 session, the Legislature appropriated additional funds in sufficient amount to continue the new ranges in force from March 1, 1964, forward. Since the original appropriation placing these new ranges in effect was limited to a period of two months, the Department of Finance has advised that actions by Appointing Powers adopting the new ranges were limited to the effective period of the appropriation.

At its meeting held on January 30, 1964, the Commission adopted the following resolution:

THE COMMISSION APPROVES THE NEW PAY RANGE ESTABLISHED BY THE DEPARTMENT OF FINANCE AS OF JANUARY 1, 1964, FOR THE POSTTION EXECUTIVE CFFICER, STATE LANDS COMMISSION, AND THE ASSIGNMENT OF THE EXECUTIVE OFFICER TO THE MAXIMUM SALARY RANGE STEP, EFFECTIVE JANUARY 1, 1964.
