APPROVAL OF MAP DELINEATING THE BOUNDARY OF STATE TIDE LAND, VICINITY OF BENICIA ARSENAL, SOLANO COUNTY, CALIFORNIA; AND APPROVAL OF BOUNDARY AGREEMENT BETWEEN THE UNITED STATES, THE CITY OF BENICIA, AND THE STATE OF CALIFORNIA - W.O. 5208.

The United States is in the process of disposing of the military reservation known is the Benicia Arsenal along the above of Sulsun Bay. The City of Benicia proposes to acquire the deactivated military reservation from the United States.

Before this transfer of property can take place, the waterward boundary must be established. The waterfront area has been subjected to artificial influence for many years. It has been agreed that the line of Mean High Tide in its last known natural state in 1896 was fixed by construction of levees and other works along the shore of Suisun Bay, and correctly represents the permanent boundary.

A map of these boundaries has been prepared by the State Lands Division and is acceptable to the United States and to the City of Benicia.

A Boundary Agreement (copy of which is attached as Exhibit "A") is also acceptable to both the United States and the City of Benicia. The office of the Attorney General previously approved boundary agreements in this form, and Staff Counsel has determined this agreement is legally sufficient.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED:

- 1. TO APPROVE AND HAVE RECORDED SHEET 1 OF 1 OF MAP ENTITLED "BOUNDARY OF MEAN HIGH TIDE LINE ALONG THE SHORE OF SUISUN BAY, VICINITY OF BENICIA ARSENAL, SOLANO COUNTY, CALIF." DATED JUNE 1964.
- 2. TO EXECUTE A BOUNDARY AGREEMENT WITH THE WNITED STATES AND THE CITY OF BENICIA FIXING THE BOUNDARY OF STATE TIDE LANDS AT THE MEAN HIGH TIDE LINE OF 1896 ALONG THE SHORE OF SUISUN BAY, SOLANO COUNTY, CALIFORNIA, AS DELINEATED ON THE ABOVE-MENTIONED MAP AND AS DESCRIBED IN THE AGRLEMENT, COPY OF WHICH IS ATTACHED AS EXHIBIT "A" AND HEREBY MADY A PART HEREOF.

EXHIBIT "A"

BOUNDARY AGREEMENT

THIS BOUNDARY AGREEMENT, made and entered into by and between STATE OF CALIFORNIA, acting by and through the STATE LANDS COMMISSION (as Party of the First Part hereinafter referred to as "the State") and

THE UNITED STATES, acting by and through the GENERAL SERVICES ADMINIL PATION (as Party of the Second Part hereinafter referred to as "United States") and

THE CITY OF BENICIA (as Party of the Third Part hereinafter referred to as "City")

WITNESSETH

WHEREAS, the State acting through the State Lands Commission is authorized by Section 6357 of the Public Resources Code to establish by agreement the ordinary high water mark or the ordinary low water mark of the swamp, overflowed, marsh, tide or submerged lands of this State, whenever it is deemed expedient or necessary; and

WHEREAS, the United States appears of record as owner of the Military Reservation bordering on Carquinez Strait and Suisun Bay in the vicinity of Benjcia, Solano County, California; and

WHEREAS, the State by virtue of its sovereignty is the owner of certain tide and submerged lands in Carquinez Strait and Suisun Bay, Solano County, California; and

WHEREAS, the ordinary high water mark as may have existed in its last natural state has been affected by artificial and natural processes or a combination of both; and 10,886

WHEREAS, the United States is in the process of disposing of the Military Reservation known as the Benicia Arsenal; and

WHEREAS, the City of Benicia proposes to acquire the desctivated Military Reservation from the United States; and

WHEREAS, the common boundary between the State and the United States is the ordinary high water mark; and

WHEREAS, the State, the United States and the City consider it expedient and necessary and in the best interests of the State and the public to describe and fix permanently the boundary between a portion of the lands belonging to the State and the United States and forever set at rest any and all questions relating to the location of said boundary line;

NOW, THEREFCRE, in order to locate, describe and permanently establish the true and correct boundary line between the State and the United States, it is agreed that said boundary line is and shall be located and established as follows:

Beginning at a point on the Mean High Tide Line of 1896 which bears S. 03° 03' 56" W., 172.03 feet from Highway Station 79+21.53, having California C'ordinst J Zone 2, X = 1,963,238.09 and Y = 138,817.81, located on the cesterline of State Highway IV, X-CC., SOL.-75, 74-MTZ., BEN. near the mortherly end of the new Martinez Bridge (said point of beginning being on the State Highway Right of Way Line); thence along the Mean High Tide Line of 1896, N. 56° E. 370 feet, N. 12° E. 150 feet, N. 7° W. 760 feet, N. 21° E. 3050 feet, N. 35° E. 950 feet, N. 17° E. 300 feet and N. 33° E. 1248.76 feet to a point on the portherly line of the Benicia Arsenal.

The bearings and distances shown in the above description are based upon the California Coordinates System, Zone 2.

This agreement shall be binding upon and inure to the benefit of the successors and assigns of the parties hereto.
