

MINUTE ITEM

9. APPLICATION FOR SUBMARINE CABLE CROSSING EASEMENT UNDER GEORGIANA SLOUGH, COUNTY OF SACRAMENTO; PACIFIC GAS AND ELECTRIC COMPANY - W.O. 5183, P.R.C. 3192.1.

After consideration of Calendar Item 36 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO PACIFIC GAS AND ELECTRIC COMPANY A 49-YEAR EASEMENT FOR THE CONSTRUCTION AND MAINTENANCE OF A 22 K.V. SUBMARINE CABLE CROSSING, AT A TOTAL RENTAL OF \$255.29 TO BE PAID IN ADVANCE, OVER LANDS DESCRIBED AS FOLLOWS:

A STRIP OF LAND 10 FEET WIDE, EXTENDING ACROSS GEORGIANA SLOUGH, LYING 5 FEET ON EACH SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:

BEGINNING AT A POINT ON THE MEAN HIGH TIDE LINE ON THE RIGHT BANK OF SAID GEORGIANA SLOUGH, FROM WHICH THE ISLETON WATER TOWER (ZONE 2 CALIFORNIA COORDINATES X = 2,112,970.98 AND Y = 180,655.17) BEARS NORTH 20° 42' WEST 5,969.58 FEET DISTANT AND RUNNING THENCE SOUTH 76° 57' EAST 240 FEET TO A POINT ON THE MEAN HIGH TIDE LINE OF THE LEFT BANK OF THE GEORGIANA SLOUGH, CONTAINING 0.055 ACRE, EXCEPT FROM THE ABOVE-DESCRIBED STRIP OF LAND THE PORTIONS LYING OUTSIDE THE MEAN HIGH WATER LINE OF SAID GEORGIANA SLOUGH. THE BEARINGS STATED HEREIN ARE BASED ON A SOLAR OBSERVATION.

APPLICATION FOR SUBMARINE CABLE CROSSING EASEMENT UNDER GEORGIANA SLOUGH, COUNTY OF SACRAMENTO; PACIFIC GAS AND ELECTRIC COMPANY - W.O. 5183.

An application has been received from Pacific Gas and Electric Company for a 0.055-acre right-of-way easement for the construction and maintenance of a 22 K.V. submarine cable crossing under Georgiana Slough near the town of Isleton, Sacramento County (see Exhibit "A").

The easement-lease is to be for a term of 49 years. Based on a staff appraisal, the rental for the total term is \$255.29, payable in advance.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO PACIFIC GAS AND ELECTRIC COMPANY A 49-YEAR EASEMENT FOR THE CONSTRUCTION AND MAINTENANCE OF A 22 K.V. SUBMARINE CABLE CROSSING, AT A TOTAL RENTAL OF \$255.29 TO BE PAID IN ADVANCE, OVER LANDS DESCRIBED AS FOLLOWS:

A STRIP OF LAND 10 FEET WIDE, EXTENDING ACROSS GEORGIANA SLOUGH, LYING 5 FEET ON EACH SIDE OF THE FOLLOWING-DESCRIBED CENTERLINE:
