## MINUTE ITEM

17. APPLICATION TO AMEND TEMPORARY WORKING AREA PERMIT, P.R.C. 3130.1, COUNTY OF SAN DIEGO; SOUTHERN CALIFORNIA EDISON COMPANY AND SAN DIEGO GAS AND ELECTRIC COMPANY - W.O. 5292.

After consideration of Calendar Item 27 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO APPROVE THE AMENDMENT OF PERMIT P.R.C. 3130.1 AS FOLLOWS:

1. DELETE THE PRESENT LEGAL DESCRIPTION AND SUBSTITUTE A NEW LEGAL DESCRIPTION AS FOLLOWS:

THOSE CERTAIN TIDE AND SUBMERGED LANDS IN THE COUNTY OF SAN DIEGO, STATE OF CALIFORNIA, DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT IN THAT CERTAIN COURSE IN THE SOUTHWESTERLY BOUNDARY LINE OF THE 83.63 ACRE PARCEL OF LAND SHOWN ON A LICENSED SURVEYOR'S MAP FILED ON JUNE 13, 1963, AS MAP NO. 6242, OF RECORDS OF SURVEY, IN THE OFFICE OF THE COUNTY RECORDER OF SAID COUNTY, SAID CERTAIN COURSE IS SHOWN ON SAID MAP AS HAVING A BEARING OF "S 58° 35' 26" E" AND A LENGTH OF "289.39 FEET", SAID POINT BEARS SOUTH 58° 35' 26" EAST ALONG SAID CERTAIN COURSE, A DISTANCE OF 70.46 FEET FROM THE WESTERLY TERMINUS THEREOF; THENCE SOUTH 58° 35' 26" EAST, 218.93 FEET; THENCE SOUTH 52° 00' 51" EAST, 299.95 FEET; THENCE SOUTH 50° 06' 17" EAST, 274.32 FEET; THENCE SOUTH 33° 00' 00" WEST, 142.72 FEET. THENCE NORTH 57° 00' 00" WEST, 790.00 FEET; THENCE NORTH 33° CO' 00" EAST, 195.65 FEET TO THE POINT OF BEGINNING. CONTAINING 3.288 ACRES MORE OR LESS;

2. DELETE THE PRESENT RENTAL OF \$2,070 AND SUBSTITUTE THE NEW RENTAL OF \$1,972.80, REFUNDING THE \$97.20 OVERPAYMENT OF THE FIRST YEAR'S RENTAL.

APPLICATION TO AMEND TEMPORARY WORKING AREA PERMIT, P.R.C. 3130.1, COUNTY OF SAN DIEGO; SOUTHERN CALIFORNIA EDISON COMPANY AND SAN DIEGO GAS AND ELECTRIC COMPANY - W.O. 5292.

By Commission action on April 29, 1964 (Minute Item 13, page 9829), the Executive Officer was authorized to issue Permit P.R.C. 3130.1 to Southern California Edison Company and San Diego Gas and Electric Company for a temporary working area covering 3.45 acres of tide and submerged lands at San Onofre, County of San Diego.

The permittees, on the basis of revised working plans, have made application to amend Permit P.R.C. 3130.1, and have submitted a new legal description reducing the temporary working area to 3.288 acres of tide and submerged lands.

In compliance with paragraph 2 of Permit P.R.C. 3130.1, the permittees have paid the first year's rental of \$2,070. Based upon a staff appraisal, the annual rental for the amended area would be \$1,972.80 (\$97.20 less than the sum already collected).

It is proposed to amend Permit P.R.C. 3130.1 by deleting the present legal description and substituting the refor the revised legal description, to change the rental from \$2,070 annually to \$1,972.80 annually effective April 29, 1964, and to refund the overpayment of the first year's rental in the amount of \$97.20.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO APPROVE THE AMEND-MENT OF PERMIT P.R.C. 3130.1 AS FOLLOWS:
