MINUTE ITEM

3. APPLICATION FOR PERMIT TO OCCUPY STRIP OF TIDE AND SUBMERGED LAND, SAN JOAQUIN RIVER NEAR LATHROP, SAN JOAQUIN COUNTY; DEPARTMENT OF FISH AND GAME - W.O. 5288, P.R.C. 3195.9.

After consideration of Calendar Item 19 attached, and upon motion duly make and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE DEPARTMENT OF FISH AND GAME A LIFE-OF-STRUCTURE PERMIT FOR THE CONSTRUCTION OF A LAUNCHING RAMP ON THE EAST BANK OF THE SAN JOAQUIN RIVER NEAR LATHROP. CONSIDERATION FOR THE PERMIT IS THE PUBLIC USE AND BENEFIT.

THE LANDS TO BE OCCUPIED ARE DESCRIBED AS FOLLOWS:

A STRIP OF TIDE AND SUBMERGED LAND 20 FEET IN WIDTH IN THE BED OF THE SAN JOAQUIN RIVER SITUATE NEAR LATHROP, SAN JOAQUIN COUNTY; BEING 10 FEET ON EACH SIDE OF THE FULLOWING DESCRIBED CENTER LINE:

COMMENCING AT THE SOUTHEAST CORNER OF THAT PROPERTY DESCRIBED IN A DEED FROM MACK SUNG TO THE COUNTY OF SAN JOAQUIN AS SAME IS RECORDED IN BOOK 1768 AT PAGE 23 RECORDS OF SAN JOAQUIN COUNTY AND PROCEEDING THENCE N. 70° 33' 32" W. 415.64 FELF AND S. 41° 35' W. 36 FEET MORE OR LESS TO A POINT ON THE MEAN HIGH TIDE LINE OF THE EAST BANK OF THE SAN JOAQUIN RIVER, SAID POINT BEING THE TRUE POINT OF BEGINNING OF THIS DESCRIPTION; THENCE RIVERWARD 3. 41° 35' W. 80 FEET; CONTAINING 0.037 ACRE MORE OR LESS.

THE SIDELINES AT THE NORTHEASTERLY TERMINUS OF THE ABOVE-DESCRIBED STRIP ARE SHORTENED OR LENGTHENED SO AS TO COINCIDE WITH THE AFOREMENTICHED MEAN HIGH TIDE LINE.

APPLICATION FOR PERMIT TO OCCUPY STRIP OF TIDE AND SUBMERGED LAND, SAN JOAQUIN RIVER MEAR LATHROP, SAN JOAQUIN COUNTY; DEPARTMENT OF FISH AND GAME - W.O. 5288.

An application has been received from the Department of Fish and Jame to construct an angling access and launching ramp on the east bank of the San Joaquin River near its intersection with Dos Reis Road.

The strip of submerged land requested for the ramp, which is to be 115 feet long, comprises 0.037 acre more or less (see Exhibit "A").

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE DEPARTMENT OF FISH AND GAME A LIFE-OF-STRUCTURE PERMIT FOR THE CONSTRUCTION OF A LAUNCHING RAMP ON THE EAST BANK OF THE SAN JOAQUIN RIVER NEAR LATHROP. CONSIDERATION FOR THE PERMIT IS THE PUBLIC USE AND BENEFIT.

THE LANDS TO BE OCCUPIED ARE DESCRIBED AS FOLLOWS:

A STRIP OF TIDE AND SUBMERGED LAND 20 FEET IN WIDTH IN THE BED OF THE SAN JOAQUIN RIVER SITUATE NEAR LATHROP, SAN J'AQUIN COUNTY; BEING 10 FEET ON EACH SIDE OF THE FOLLOWING DESCRIBED CENTER LINE:

COMMENCING AT THE SOUTHEAST CORNER OF THAT PROFERTY DESCRIBED IN A DEED FROM MACK SUND TO THE COUNTY OF DESCRIPTION AS SAME IN A DEED FROM BOOK 1768 AT THE COUNTY AND PROFESDING THAT IS A TEXT OF THE WAY HIGH TIDE LINE OF THE RAST FACT OF BEGINNING OF THIS DESCRIPTION; THENCE RIVERWARD S. 41° 35' W. 60 FEET; CONTAINING 0.037 ACPE MORE OR LESS.

THE SIDELINES AT THE NORTHEASTERLY TERMINUS OF THE ABOVE-DESCRIBED STRIP ARE SHORTENED OR LENGTHENED SO AS TO COINCIDE WITH THE AFOREMENTIONED MEAN HIGH TIDE LINE.
