APPLICATION FOR LIFE-OF-STRUCTURE PERMIT FOR THE CONSTRUCTION OF IWO GROINS ON STATE TIDE AND SUBMERGED LANDS, PIERPONT BAY, VENTURA COUNTY; COUNTY OF VENTURA - W.O. 5373.

An application has been received from the County of Ventura for approval of a life-of-structure permit covering the construction and maintenance of two groins on State-owned tide and submerged lands on Pierpont Bay within the city limits of Ventura. The construction of the groins is part of a beach-erosioncontrol program recommended by the U. S. Army Corps of Engineers. The project is to be undertaken jointly by the County of Ventura, the U. S. Army Corps of Engineers, and the Division of Beaches and Parks, with the County maintaining the groins after completion of construction.

The project is the second phase of an erosion-control program that was begun in late 1961 for the protection and restoration of public beaches in the Pierpont Bay area of Ventura. At its meeting of January 22, 1962, the Commission authorized the construction of three groins under Permit P.R.C. 2830.9; the authorized groins are identified as numbers 1, 2, and 4; the proposed groins are identified as Groin No. 5 (Parcel A) and Groin No. 7 (Parcel B) (see Exhibit "A").

The consideration for issuance of the permit is to be the public benefit.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A LIFE-OF-STRUCTURE PERMIT TO THE COUNTY OF VENTURA FOR THE CONSTRUCTION OF TWO GROINS ON PARCELS OF THE TIDE AND SUBMERGED LANDS DESCRIBED AS FOLLOWS:
