Signal Oil and Gas Company, a Delaware corporation, is the owner of the 100% working interest in State Oil and Gas Lease F.R.C. 426.1, issued on February 10, 1950, to said company pursuant to competitive public bidding in accordance with Division 6 of the Public Resources Code. An application has been received from Signal Oil and Gas Company for approval of the assignment of an undivided interest in Lease P.R.C. 426.1 to each of the following: Pauley Petroleum Inc., Edwin W. Pauley, John B. Elliott, John C. Elliott, Henry H. Clock, John G. Clock, Maude H. Clock, and R. A. Waestman.

The lease provides for the assignment of interests in the lease, with the approval of the State, to corporations or individuals possessing the qualifications required by the Public Resources Code. The aforementioned assignees have submitted evidence showing that they possess the qualifications necessary to satisfy the Code requirements. The bond requirements of the lease have been fulfilled by the assignees. The form of assignment has been executed by Signal Oil and Gas Company and the assignees. Statutory filing fees have been paid by the applicants.
