QUITCLAIM OF MINERAL EXTRACTION LEASE P.R.C. 1444.1, STANISLAUS COUNTY; EDWARD KLEIM - W.O. 5386.

Mineral Extraction Lease P.R.C. 1444.1, issued on October 7, 1954, to Edward Kleim pursuant to competitive public bidding, covers land lying in the bed of the Tuolumne River between the northerly and southerly lines of low water, bounded on the west by a line parallel to and 700 feet east of the west line of Section 2, T. 4 S., R. 10 E., M.D.B.& M., and on the east by a line parallel to and 1,500 feet east of the west line of Section 2, T. 4 S., R. 10 E., M.D.B.& M., all in the northwest corner of Section 2, T. 4 S., R. 10 E., M.D.B.& M., Stanislaus County, and contains 15 acres more or less.

Record review by the staff discloses that 175,917.61 cubic yards of sand and gravel have been extracted and sold from the lease area. Cumulative royalty amounting to \$1,927.74 has been paid. The annual rental for the lease year ending October 7, 1965, and all royalty due have been paid. Mr. Edward Kleim has submitted a quitclaim deed dated October 39, 1964. Section 17 of the lease provides, in part: "...this lease may be terminated...by mutual consent of the parties".

Field reconnaissance has shown that all appurt mances had been removed and that the lease area has been restored as nearly as possible to the condition existing at the date of execution of the lease.
