13. APPLICATION TO LEASE STATE-OWNED TIDELANDS FRONTING EL SEGUNDO STEAM GENERATING STATION AT EL SEGUNDO, LOS ANGELES COUNTY; SOUTHERN CALIFORNIA EDISON COMPANY - W.O. 5316, P.R.C. 3266.1, P.R.C. 3267.9.

After consideration of Calendar Item 16 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO SOUTHERN CALIFORNIA EDISON COMPANY:

1. A LEASE FOR A PERIOD OF SEVEN MONTHS BEGINNING AUGUST 28, 1964, AND ENDING MARCH 27, 1965, FOR USE AS A GENERAL CONSTRUCTION AREA, AT A TOTAL RENTAL OF \$3,078.25, COVERING LANDS WHICH ARE DESCRIBED AS FOLLOWS:

A PARCEL OF ARTIFICIALLY ACCRETED LAND IN THE CITY OF EL SEGUNDO, LOS ANGELES COUNTY, CALIFORNIA; BEING FURTHER DESCRIBED AS FOLLOWS:

APPLICATION TO LEASE STATE-OWNED TIDELANDS FRONTING EL SEGUNDO STEAM GENERATING STATION AT EL SEGUNDO, LOS ANGELES COUNTY; SOUTHERN CALIFORNIA EDISON COLLANY - W.O. 5316.

Lease P.R.C. 2928.1 and Permit P.R.C.2929.9, covering State-owned tidelands at El Segundo, Los Angeles County, were issued to Southern California Edison Company for a two-year term beginning August 28, 1962. The lease provided a general construction area in connection with a \$44,000,000 expansion of the existing steam-electric generating plant located on the adjacent upland. The permit covered the deposition of surplus dune sand from an upland excavation on the State-owned tidelands. The material is carried downcoast by littoral wave wash and contributes to the build-up of downcoast banches.

On June 24, 1964, the Commission approved a boundary him agreement between the State of California and the Southern California Edison Company, which fixed the boundary between the State and the company.

Since the original lease and permit had no provision for a renewal option, the company has applied for another lease and permit (see Exhibit "A") for a sevenmenth period from August 28, 1964, to March 27, 1965, by which time clean-up work will have been completed and the site cleared. The rental for the 2.019-acre lease area has been computed to be \$3,078.25.
