Calendar Items 29 and 30 attached were presented as a unit, inasmuch as they are closely related.

Mr. Richard Golden, of the Budgets Division of the Department of Finance, reviewed in detail the report on proposed staffing requirements that had been submitted previously to the members of the Commission. A copy of this proposal is being made a part of these minutes by reference to the official files of the Commission in its Los Angeles office.

The Chairman suggested that the Executive Officer should anticipate needs for additional staff, and call upon the Commissioners for direct help in obtaining necessary budget allotments if and when approval cannot be obtained without but help.

UPON LOTION DULY MADE AND CARRIED, A RESOLUTION WAS ADOPTED APPROVING THE STAFFING REPORT (UNDATED) PREPARED BY MR. RICHARD GOLDEN OF THE DEPARTMENT OF FINANCE, BOYGET DIVISION, IDENTIFIED AS REGISTER NO. 0398 OF MARCH 23, 1965, WITH THE ADDITION OF ONE POSITION OF ADMINISTRATIVE ASSISTANT FOR PLANNING AND RESEARCH, SAID ASSISTANT TO BE RESPONSIBLE TO THE NEW ASSISTANT EXECUTIVE OFFICER, AND ONE POSITION OF SENIOR STENOGRAPHER-CLERK.

UFON MOTION DULY MADE AND UMANIMOUSLY CARRIED, THE "MANAGEMENT PROGRAM AND STAFFING REFORT", DATED MARCH 16, 1965, PREPARED BY DeGOLYER & MacNAUGHTON, CONSULTANTS TO THE STATE LANDS COMMISSION, WAS ACCEPTED AS TO INITIAL STAFFING RECOMMENDATIONS.

Commissioner Granston, in considering the DeGolyer & MacNaughton report, stated that, inasmuch as he had received a copy of the recommendations only late the previous afternoon, he had not had an opportunity to make a detailed analysis thereof, and therefore wanted to reserve comment about the suggestion in the report that most of the additional large staff being proposed should be kept throughout the life of the field; i.e., the full thirty-five years.

Commissioner Champion commented on the difficult recruitment problem that would be involved, and asked that the Legislature be requested to make the money available for the positions also available to hire consultants in lieu of civil service employees, if necessary.

On July 28, 1964 (Minute Page 10, 314), the Commission adopted the following resolution:

"THE EXECUTIVE OFFICER IS DIRECTED TO REQUEST THE DEPARTMENT OF FINANCE AND THE DEPARTMENT OF GENERAL SERVICES TO INITIATE A STUDY OF THE STATE LANDS DIVISION, WHICH STUDY WILL (A) REVIEW THE PRESENT CRGANIZATION AND STAFF OF THE DIVISION AND (B) LIVELOP A PLAN TO PROVIDE FOR AN ORGANI-ZATIONAL STRUCTURE AND STAFFING IN CONFORMANCE WITH CURRENT AND NEAR FUTURE GROWTH REQUIREMENTS."

Hursuant to this request, the Director of Finance directed that the required studies be undertaken by the Department of Finance. The result of these studies and recommendations for implementation of an organizational structure and staffing in conformance with current and near future growth requirements will be reported by the Director and a representative of the Department.
